Helpline:

Hello family, my name is Russ and I'm an addict. We had 14 people attend helpline, with a total of 3 new members. We took 763 calls for 2,048 minutes and 58 seconds. We took 23 voice messages.

We looked at whether or not having a yellow page add affected our calls. I called Line 1 and they told me that last year's calls vs this year's calls are as follows:

October 2009 – 423 October 2010 – 465 November 2009 – 516 November 2010 – 585

We are also in the process of fixing the message board and the phone coordinator is changing the message board. We also looked at putting the NA Helpline phone number on bus benches in the area. In Loving Service, Russ

H&I:

Hello family, my name is Stephanie and I'm an addict. In last month's report we stated that we began a new H&I presentation at Amethyst Respite Center, this information was incorrect. The correct name of the facility is The Acute Recovery Center at the VA Hospital.

H&I met today with 45 members present. Of those, we had 7 new members.

Our panel coordinator met with the Program Coordinator at the Hillsborough County Sheriff's Office (HCSO) to discuss H&I's concerns with the increased difficulty in obtaining PV numbers. During this meeting our H&I coordinator was presented with HCSO's new criteria to obtain PV numbers. HCSO understands H&I's concerns; however, their new policy is non-negotiable.

Our coordinator also met with the case manager at Amethyst Respite Center to discuss their interest with having an H&I presentation carried on a weekly basis. The H&I coordinator brought back a report from the meeting with the facility. We voted to table further discussion on this issue to next month.
