RCM Report:

The GSR assembly was held in Orlando and had a total of 46 GSR's and 5 alt GSR's in attendance from all areas of our region. The Tampa area ballots turned in at our last area were given to the regional secretary for counting. Our area (FunCoast) turned in 39 ballots out of a total of 116 that were turned in.

The tally of votes are located within the minutes located on the regional website .

Below is a carry over from the last regional meeting as with the GSR assembly taking place the fellowship development and area support group did not meet,

In old business, we had 6 participants from PR at the MOSI event on March 31th, called Celebrate Life! DEA: Drug Awareness Day. We were in attendance with such other organizations like: DACCO, Operation Par, and Town and Country Hospital. The

event coordinator reported to us that the event was a success, in spite of the brief torrential downpour of rain in the middle of it. New Business:

In new business, we were asked to carry two different presentations this past month. The first was at the Salvation Army ARC, where we met with the new program director there, as one of our members is making an effort to reconstitute the open meeting that was there previously. The second presentation was at the new St. Joseph's Behavioral Health Unit, which asked for representation by our fellowship for the benefit of their patients. This presentation resulted in a need for a new H&I panel to carry a message of recovery into their inpatient residents.

Next, an update to the Tampa Funcoast Website involved the addition of another section under Area Services that would provide some information about the Newsletter subcommittee. This new section will be uploaded before the next ASC.

Additionally, one of our directives in the next few months is to try to put a small literature rack into the Salvation Army ARC and V.A. Hospital Outpatient Treatment area, where we would do our best to make available a selection of Narcotics Anonymous IPs

Lastly, we have gotten some feedback from our members that the process to update the Tampa Funcoast Website for meeting schedule changes is not happening as quickly as it should. Function

Online Guidelines

Meeting change requests must be submitted through area in order to be updated on the website. NA members personal contact information will not be published on the site. This includes phone numbers, postal and email addresses, and where possible last names shall be omitted.

Web Page Link Guidelines

The website will link to the following: NA World Services, Florida Region, NA literature and neighboring area websites. ASC minutes, newsletter, events flyers and subcommittee minutes may be posted on the website. The editor will remove past event flyers bi-weekly from the website.

Duties and Responsibilities

Administrator: Chair and Vice Chair of the Public Relations subcommittee.

Responsibilities:

- 1. Keep hosting account and domain registration current.
- 2. Update the Contact Us page emails with those who currently hold subcommittee and Admin body positions.
- 3. If needed, perform minor adjustments to the website layout, structure, or functionality. If this cannot be accomplished by the Chair or Vice-Chair, then the work must be contracted out to a Special Worker selected by the subcommittee after receiving no less than two bids for the work, which must be supported by the current Public Relations budget.

Editor: Any willing Public Relations member may be elected by the committee to hold this position for a period of three months, as long as they also meet any qualifications.

Responsibilities:

- 1. Update meeting schedules and, if needed, Subcommittee Meeting times at the end of each month, when the hard copy schedule changes are submitted to the printer.
- 2. Upload ASC Documents to the appropriate Downloads section: ASC Minutes, Budgets, Newsletter, and the soft copy Meeting Schedule provided by the printer.
- 3. Upload Events and Flyers and update the calendar with the Event details, such as: Picnics, Dances, Special Events, Home Group Anniversaries, Activities Events, changes to Subcommittee Meetings, and the like.
- 4. Respond to any website updates via email when the request is processed, and copy the response to the Chair and Vice-Chair to insure the updates are being completed.
- 5. In the event the Editor cannot fulfill his or her responsibilities, they will be fulfilled by the Chair or Vice-chair.
- 6. Meeting schedule changes must be handed off to the current Website Editor within 1 week of the ASC when the changes were picked up. (e.g. If ASC was on April 14th, then the meeting schedule changes should be submitted to the Website Editor no later than April 21st)

Qualifications

Administrator: Must hold the position of Public Relations Chairperson or Vice-Chair.

Editor: Must have a minimum of six months clean
