Please indicate whether you want your minutes MAILED, EMAILED or NOT Mailed in the far right column of the contact sheet. This is to insure that your group receives their minutes in a timely fashion. If you are a new Subcommittee Chair please be sure to update the contact sheet as well. For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports in typed format, you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as

time or location can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be tuned in before we discuss todays New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$135.05 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports for the month of September. \$159.43 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports for the month of October.

At today's GSR Orientation there were 6 in attendance.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: **Welcome Home.** "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. Public Relations:

The Public Relations subcommittee met today at 1:00pm. There were 12 members present and 3 new members. We opened the meeting with the Serenity Prayer.

There were 1400 copies of the meeting schedules printed this month and there were 9 changes to the following meetings: The Ties That Bind Us, Sunset at Sunrise, A New Way, Addicts Salvation, fresh Start, Women Do Recover, Arc of Hope, and Welcome Home. The Tampa Funcoast Website had **2593** unique visitors in October, which was an increase of 216 visitors from the month of September. Please remember that you can send any correspondence, updates, suggestions, event flyers, and the like directly to us by clicking Contact Us in the navigation bar and selecting "Website Info" as the department.

Old Business: We were able to fill the new positions in the Public Relations subcommittee that included a person to distribute our literature to facilities and another to update our meeting schedules.

Next in old business, we were invited by N.O.P.E. (Narcotics Overdose Prevention and Education) to attend a candlelight vigil in downtown Tampa. The vigil occurred from 7pm to 8pm on October 25th, and included guests such as Florida's Attorney General, and a Hillsborough County Judge who has been responsible for sending many recovering addicts to the rooms of Narcotics Anonymous.

Lastly, two of our subcommittee members gave a presentation at Unified Learning Day on November 3rd to inform NA members about the responsibilities and goals of PR members, as well as individual member behavior in the fellowship.

New Business: We discussed the policy of the Public Relations subcommittee to determine whether or not we should include the new positions in our policy for literature distribution and meeting schedule changes. This decision will be tabled for December to determine what effect this will have on the future PR subcommittee. Also, when we bring a presentation to professionals in our community, we haven't had a written presentation format to follow. To be consistent with our presentations, we have decided to adopt the format used for a presentation to professionals as created by the WSO. Next, in new business, in our attempt to increase the scope of the Public Relations subcommittee, we discussed carrying the Narcotics Anonymous message into Hillsborough County Schools. We have appointed two PR members to head a task force that will put together a letter to school administrators.

Lastly, we revisited the idea of having a public service announcement on local radio stations. This item was dismissed due to our current budget and lack of not-for-profit status, but may be able to happen with some stations on the AM band.
