LDO Report: *LDO: Ron H.; Alt. LDO: Yulee S.* Given by Ron. Hello family my name is Ron and I am an addict. Last month's inventory was \$831.37. This month's literature order was \$3,448.22 with an 8% discount. I would like to thank Yulee, Alt LDO, Jimmy and John for their help pulling orders today.

RCM Report: *RCM#1: Andy C.; RCM#2: Gilbert O.* Given by Andy. The Region Service Committee met in Jacksonville on November 19th and 20th. Lisa C. was a work group leader and she gave a report about what areas in the region believe it takes for a well-functioning ASC. The overwhelming feeling is good leadership is necessary to maintain the structure and fluidity of the meeting as well as maintain an atmosphere of recovery. We met as smaller groups with various topics and I sat in on a leadership Workshop. This mainly was about what qualities to look at in an ASC chairperson. The consensus was that communication, adherence to ASC policy, and maintaining order were the most desired. Tampa Funcoast directed us to find out more about non-profit status. Yes we can go under the RSO umbrella for 501c3 status. I have the phone number for the office of the treasurer so our admin can contact him for more information. As a point of information, other areas in the Florida region that have Behind the Walls meetings are represented at those areas' as non-voting groups. A lot of time was time was dedicated to Issue Discussion Topics also known as IDT's, that are highlighted for the World Conference. Three major points are, number 1) applying the principles and Concepts to social media. Number 2) maintaining an atmosphere of recovery in service. Number 3) how to use: Guiding Principles, the Spirit of Traditions, also known as the traditions workbook. Region offered to send a group leader to speak to any area requesting information on the statewide phone system and how it functions. I talked to the Heartland Area RCM and he will inform them about our moving forward with an ad-hoc to discuss joint convention ideas and suggest they do the same and hopefully depending on our findings, we would form a joint committee in the future for our two areas. Okay now this is a big deal. The 2017 regional GSR Service Symposium is at the Tampa Sheraton East on MLK and Falkenburg March 23-26, 2017. Registration is free and the Symposium is open to anyone wishing to really get deeper into service topics. I've been to several of these programs and sadly to say, even though it's usually in Tampa, our area has among the weakest attendance. So please show up for the right reason and leave refreshed for service. We have been given four room Nights by region for GSR's and I have a male and a female in the area who already are reserved. So if there are any other GSR's who want to spend a night or two let me know by the end of today's area. You can register online at na.florida.org and go to the link for service Symposium in March. Now the host area puts some small event together for regional reps from around the state which takes place at the same time as the symposium usually a Saturday night. Gilbert will get with activities subcommittee to coordinate. A recent region I attended had an ice cream social and speaker meeting at a local Clubhouse similar to YANA and was very successful I'm just saying I like ice cream. Also if GSR's and sub committee chairs, all members, will take time to write down and submit to me any ideas for discussions as service topics for the symposium I would appreciate that I will turn them over to region before the symposium. Lastly, the Florida Regional Convention of Narcotics anonymous is in July in Orlando and Gilbert has pre-convention shirts for sale. Also RSC is asking for Direction to go forward in principle to study the idea of buying property to have RSO headquarters. RSO is the regional service office and is a separate entity to conduct business for the RSC the regional service committee so take that back to your home groups and discuss that and use consensus-based decision-making and remember if you block the idea you have to cite what step tradition or concept that project would violate.
