This is to insure that your group receives their minutes in a timely fashion. If you are a new Subcommittee Chair please be sure to update the contact sheet as well. **For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports in typed format, you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as time or location can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be turned in before we discuss today's New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$204.25 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports for the Month of December 2012.

At today's GSR Orientation there were 2 in attendance. Please be sure to announce the GSR Orientation to all your groups.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: *(There are no Groups removed this month)* "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

The Tampa Funcoast Website had **2744** unique visitors in December, which was an increase of 65 visitors from the month of November. Please remember that you can send any correspondence, updates, suggestions, event flyers, and the like directly to us by clicking Contact Us in the navigation bar and selecting "Website Info" as the department.

Old Business-We have successfully completed the migration to the BMLT (Basic Meeting Locator Toolbox). Many thanks go to our current website maintenance person, Charlie A. for migrating all of our meetings. You can now see a running total of meetings per week on our home page, as well as a map interface, and a page displaying all the days of the week. If there are any omissions or errors, please point out the errors so that they can be immediately corrected. After speaking with a representative at the Metro Bench Company, we have received a design composition and have agreed on pricing for the procurement of 5 bus benches in Hillsborough County. Although drug use is everywhere, we have been assured that we can have our contact info visible to people in areas that are considered by many to have high drug use, crime rates, and homeless rates. Some of those areas include: Sulfur Springs, Robles Park, College Hill, and an area in North Tampa that has been nicknamed "Suitcase City" by Tampa residents. This would incur a 1st year fee of \$1000 for their setup and \$600 per year to maintain them, which is the pricing given to not-for-profit organizations. Please look for this line item in the 2013 Public Relations Budget. Also, if there are any other suggestions for location, please let us know.

Once again I wanted to reiterate our next poster hanging event where we will be meeting on Saturday, March 2nd at 9am. The meeting place we have chosen is the McDonalds on Waters Ave and Florida Ave. Please join us in making Narcotics Anonymous more visible to those addicts who have not yet found us.

New Business-We have been asked to help provide a speaker at the University Of Florida College Of Pharmacy who has a story involving the abuse of prescription pain medication. This person would be speaking to pharmacy students at the college. We will not have dates for the speaker until next week, but if anyone would like to suggest a speaker in this professional environment, we are open to suggestions.

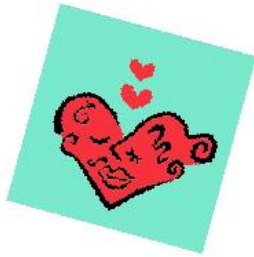
