Please indicate whether you want your minutes MAILED, EMAILED or NOT Mailed in the far right column of the contact sheet. This is to insure that your group receives their minutes in a timely fashion. If you are a new Subcommittee Chair please be sure to update the contact sheet as well. For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports typed you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. My email address is acmorales@me.com.

Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as time or location can be put in the GSR report box as well. GSR/Alt GSR must fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be tuned in before we discuss todays New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$128.81 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports.

At today's GSR Orientation there were 4 in attendance. A flyer for the orientation was created and sent in the minutes. Please be sure to announce the GSR Orientation to all your groups.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: NONE. "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

FRC is having a contest-area with most pre-registrations will be given preferred seating at the sat eve speaker meeting...deadline May 1st. They are also asking home groups to sign-up to chair marathon meeting at the convention, you can sign-up on-line at the regional website. The next RSC will be in Orlando May 18-19 and the FRC fun raiser that Sat night will be a Cartoon Character Themed Dance.

March Service Symposium – There were 347 registered which included 30 Professionals, 182 individuals from FL Region, 27 from the SFL Region and 108 from out of state including 1 from Canada. There were 80 room nights for Areas budgeted but only 30 were used.

Fellowship Development A re-entry fair took place at Marion Correctional where NA was represented. Information about NA as a resource in the community was presented to members of the DOC and the local area. They will discuss more on the possibility of starting a BTW self sufficient meeting. FD is in the process of utilizing local NA newsletters as a resource to attract members to participate in the writing steps in recovery project.

An introduction letter was drafted and presented to the FRCNA Board president for their review. This is the same letter that is going into the facilities of the Florida State Prisons, treatment centers, and local jails to broadcast the FRCNA Saturday night speaker meeting from this year's convention. In August, FD will attend the FADAA Annual Conference in Orlando. They expect over 1000 professionals in the Behavioral Health field to attend.

PR Coordinator Regional PR is planning to attend the 2013 Community Health and Wellness Conference in Lake Buena Vista, FL. This is a fairly new conference put on by FADAA and sponsored in part by DCF. Approximately 500 professionals in the Behavioral Heal, General Healthcare Workers, Doctors and Community Leaders are expected to attend. The attendees represent a slightly different audience for them and they are excited about the opportunity to carry the NA message to these professionals.

<u>WorkGroups Update:</u> Literature in Pharmacies workgroup is completed. The results are that local area PR committee's should have no problem approaching Mom and Pop pharmacies. The large corporate pharmacies are a different story and there was no success with communicating the need for racks in their pharmacies.

Secretary Report: No cost of printing. Asked for H&I members to announce in meetings that H&I needs help. Panel Coord Report: All meetings at HCSO FRJ have been suspended. Men's meetings time was moved to 8pm to 9pm. 2 panel members were given the run-around as to where to enter the jail for volunteers going into programs. Because if a shift change going on, inmates arrived almost 30 minutes late and were told they would not get credit for attendance. It was a very unpleasant experience for the panel members. HCSO is in the process of hiring a Senior Treatment Counselor and hopes to re-energize NA at FRJ.

Concerns: VA hospital having difficulty getting their clients to the meeting on time, if at all. Panel member at DACCO R3 wasn't following guidelines. Staff contacted our panel coord about the issue. Individual has stepped down from that commitment.

New Business

We had an open forum for 10 minutes, and there was a motion to close and a second to that motion. We closed with reading of the Third Step Prayer.



Regional Business (3 Topics)

(1) Proposal #01-03-13 (Bahamas/Bermuda Outreach Workgroup) (Groups to bring vote to May ASC)

Proposal –To revise two line items in the Admin Budget from FRSC Bahamas and FRSC Bermuda to read Bahamas Workshop Travel and Bermuda Workshop Travel. The amount of \$3600 for each line item is to remain as is.

Rationale — Because of the difficulty of travel to the US for these two areas and the difficulty in finding trusted servants willing to travel to the US for six Regional Service conferences another way is being sought to carry the message of service and NA news and events to these two Island nations that belong to the Florida Region. The Bermuda Area has also just recently requested that the Florida Region come to their Area to conduct workshops specifically on Service as well as presentations regarding the current Service Structure and the proposed service System. The Bahamas Area has requested this of us several times since 2006.

Sending a delegation of two trusted servants well versed in Service and with an ability and a willingness to not only travel freely outside the United States but to also spend two full days conducting presentations and workshops to the local fellowship has the potential of reaching many more addicts directly than when one individual attends a Regional Service conference sporadically. A new level of enthusiasm could be stimulated in the local fellowships of these two areas and entice more members back to participating in order to build a stronger network of recovering people on the islands. The Florida Region and the Bahamas Area experienced just these results after we brought a Regional Service conference to the Bahamas in 2006. While the enthusiasm lasted several months and it appeared that this could be sustained, what resulted was a gradual slide back into the complacency that was felt prior to our RSC in that Area. A sustained effort on the part of the Florida Region along with continued participation from each of these two local fellowships may assist in building stronger home groups, keeping long time members involved in order to mentor newer members to carry on in service on these islands, educate the professional community further about Narcotics Anonymous, give local addicts a safe haven and a viable choice for recovery.

Small isolated (geographically) fellowships experience challenges that we may not experience and may require special effort and support in order to sustain a strong fellowship.

Financial and Spiritual Impact — currently there is \$3600 per Area per budget year for each Area to send a representative to our Regional Service Conference. The reality is that travel is not always possible for these two areas when the RSC meets. The workgroup's research also found that it was generally (almost unanimously) agreed that one person receiving information and then disseminating that information would not be as impactful as two people disseminating information to a larger number of people directly. Visual Aids would further enhance that message. New faces and new voices also have a stimulating affect on people who may have been hearing the same voice and the seeing the same faces many many times. Since currently there would be no budget change but the potential for reaching more addicts increases exponentially the financial impact to the Region as a whole and to the Bahamas and Bermuda Areas specifically is extremely positive and long lasting.

(3) Discussion Topic: Predatory Behavior (Questions from groups to be brought to May ASC)
Predatory Behavior is a manner of behaving or acting that can become overbearing, greedy, and always has selfish motives.

Every individual is precious to the group, and the group is precious to the individual. We never experienced the kind of attention and personal care that we found in the program. We are accepted and loved for who we are, not in spite of who we are. No one can revoke our membership or make us do anything that we do not choose to do. If a predator interferes with our purpose, then addressing that becomes part of our primary purpose.

Some things to think about:

Obsessive behavior is a common denominator for addictive people. We have times when we try to fill ourselves up until we are satisfied, only to discover that there is no way to satisfy us. Part of our addictive pattern is that we can never get enough. Sometimes we forget, and we think that is we can just get enough food or enough sex, or enough money we'll be satisfied, and everything will be all right. Self-will still leads us to make decisions based on manipulation, ego, lust or false pride. We don't like to be wrong. Our egos tell us that we can do it on our own, but loneliness and paranoia quickly return. We find that we cannot really do it alone; when we try, things get worse. We need to be reminded of where we came from and that our disease will get progressively worse if we use. This is when we need the Fellowship.

How can we "enforce" or encourage a group to address a problem individual or encircle a vulnerable person? Yes, the group's autonomy stops when their actions or lack thereof affect NA as a whole, but I've seen examples of groups that were resistant to an areas please/requests.

We're not here to protect or prosecute. If someone is placing someone else in danger, it may need to be addresses outside the group/NA, not as addicts, but as friends and sponsors.

Encourage Area to encourage groups to regularly inventory themselves as to whether or not they are creating an atmosphere of recovery.

This stated in a different context – We don't represent or speak for NA, however this is something to think in addressing this issue. How do we confront the predator or the victim?

Either of them might not see the confronting person(s) as friends trying to help, but rather "The Group" or "The Fellowship" meddling in their life. This is something we as a group would have to think about to come up with a solution.

While autonomy gives us certain freedoms, it also implies responsibility for our actions and for the continued wellbeing of NA. As groups, we exercise our responsibility to the fellowship by taking inventory of our behavior and how we hold meetings. Our group exercises its autonomy in a responsible way when it takes care to consider the common welfare of the fellowship as a whole before it acts.

Something happens when we practice the steps and learn to apply principles in our individual lives. We develop an awareness of our behavior and its effects on ourselves and others. In other words, we develop a conscience. The conscience is a reflection of our relationship with a Higher Power.

Membership is a personal decision reached by each individual. We can do a lot to allow addicts the freedom to make that decision and reaffirm their commitment to recovery. We can help them feel comfortable in our groups by greeting them at the door, sharing with other addicts before or after the meeting, and exchanging telephone numbers. We try to make sure that any addict who attends our meeting is not turned away. To the extent that it's possible, we choose the most accessible location for our meetings. We may choose a format that reflects an invitational tone. Most of all, we encourage every addict to keep coming back.

The group will also want to examine its identity as a group. When we were using, most of us looked out for ourselves and ourselves alone, not giving any thought for one another's welfare. An NA recovery group, on the other hand, is founded on it members' commitment to one another.

Does the Tenth Tradition tell us that, as individual recovering addicts, we must not talk in NA meetings about challenges we face? No. It does not. While a particular problem may be an outside issue, its effect on our recovery is not; everything affecting an addict's life is material for sharing. If a problem we are having impacts our ability to stay clean and grow spiritually, it's not an outside issue. Many things can put us off balance and challenge our recovery. We often discuss such challenges with one another at our meetings, seeking to ease our personal burdens by sharing them with our fellow NA members. We ask others to share how they have applied the principles of the

program in similar circumstances, recovering their balance and strengthening their recovery. We need no one's permission to talk about such things in our meetings.

The conscience of a group takes shape and is revealed when its members take the time to talk with each other anout their personal needs, the needs of that group, and the needs of NA as a whole. Each member draws upon his or her relationship with a Higher Power when sharing with the group. As member listen carefully to each other and consult their personal understanding of a loving God, something happens; Solutions to problems become apparent, solutions that take into consideration the needs of everyone concerned.

Our best talent in service is the ability to reach other addicts, offer identification and welcome, greet the addict walking in the door for the first time, and help ensure that newcomers return again and again. Any one of us is capable of offering that service. With the guidance of a loving Higher Power, we become better able to help others and part of our responsibility as a group is to keep an atmosphere of recovery and part of the atmosphere is ensuring that all addicts have a safe place to go.

Some recommendations/Suggestions that may be helpful

- It is the responsibility of every home group member to be the eyes and ears of other members and look out for predatory behavior in anyone
- Have 2-3 home group members discuss with the offending member after the meeting
- Make a "no predatory behavior tolerated" statement as part of the meeting format
- Discuss that this type of behavior is not just sex, it is also money, clothing, rides, places to live; it could
 evolve into many behaviors
- Confront your friends if they're guilty of predatory
- Home group members should take the lead in making everyone feel comfortable walking the walk that
 everyone is welcome regardless
- · Get out of your own comfort zone and reach out to groups isolated geographically, by common culture
- Creating and maintaining atmosphere of recovery is up to each individual member by setting a personal
 example for others to follow we can prove that no addict, anywhere, need die from the horrors of addiction

Locally Developed Resources Predatory Behavior in Narcotics Anonymous

This information has been gathered by addicts, for addicts about a behavior that has potentiality to damage, destroy lives and create havoc in the fellowship. Collectively and individually addicts have been expressing concern about the health and welfare of our fellowship if this behavior does not abate. There are local and state officers, whether they are drug court or probation officers, etc that will not send their probationers or offenders to narcotics Anonymous. Many people who could be potential members are not able to hear the life changing message of Narcotics Anonymous. There is a reputation in some areas that people sent to NA are not safe and are preyed upon by other members. Our hope is that we can bring to light some information that will help recovering addicts identify when there has been concern and how to deal with the situation if and when it arises. Most of all it will hopefully cause people who are engaging in predatory behavior to take a good long look at just how damaging this behavior can be to addicts in our fellowship and those who have yet to join us.

PREDATORY – of or living by plundering and robbing, preying on other animals PLUNDERING – to take by force of fraud BEHAVIOR – way of behaving, conduct or action. Something that can be observed and measured

The definitions for predatory or plundering behavior can conjure visual images of large birds of prey like hawks or eagles, etc, hunting and preying on other smaller, slower animals, those less able to protect themselves. They do this as a means of survival; this is how they are able to eat. The predators we are discussing here are a different kind of predator; human predators. Human predators prey on people who they deem weaker than, not as important as, expendable, easy prey, lame, defective, or unable to protect themselves, etc. The term predator is used as a label for anyone who "preys" upon others. The predator may not even realize that this is how they view the people they are preying upon. They may also not see themselves as predators. Sometimes the person is unaware of what they are doing, other times the individual is very aware of the behavior and is making a

conscious decision to participate or act out in the behavior.

When we think about predatory behavior in the fellowship of Narcotics Anonymous, I am sure we can all come up with scenarios or pull from our own experiences of being either predator, prey or witness to these scenarios. We come to the rooms of Narcotics Anonymous from varying walks of life for varied reasons and in various stages of addiction. Some of us turn from prey into predator. Often times, some of us have been abusers. People come to the rooms for differing reasons. Not everyone who is in the rooms is here to "...stop using, lose the desire to use and find a new way to live". Some of us weren't parented or didn't have adequate role models. Some of us were raised in decent loving homes and strayed from that path. Some come to the rooms through the criminal justice system. We all arrive in the rooms of because something is wrong with the way we are living and we need to find a different way to love. Many arrive at the doors of Narcotics Anonymous broken, battered or badly damaged by the disease of addiction and the lengths we had to go to so we could continue using. Many of us arrive with the scars of addiction and/or abuse evident on our physical person, others carry those wounds deep within. You may not be able to see them but the scars are there. People arrive in NA trying to get clean, stay clean or maybe they come because they want the pain to stop and they fall victim to other people who are using to get their own selfish, self-seeking, self centered needs met. When we get in the way of newer people building a foundation of recovery we do them a huge disservice. We hinder their ability to build necessary relationships that are vital if they are to stay clean.

When we think of predatory behavior we may only think about sexual predator but there are many kinds of predators in our midst. Examples of predatory behavior can be: borrowing money with no intention of paying it back, borrowing possessions, "bumming" cigarettes, etc from a person you know is unable to say no. It could be someone selling or attempting to sell drugs in or around the meetings. It could be an attractive woman currying favor from a man to get money, or things. It could be a person with time "scooping up" a newcomer and beginning a relationship with someone who is newly clean (Thirteenth Stepping). Many people will resort to getting involved in relationships the drugs go. It is one of the most prevalent and natural decisions people make when getting clean. Using relationships is very common when people are getting clean. When the drugs go people look for something outside themselves to fill the void left by active addiction. Often times the newcomer is excited or thrilled that someone "with time" is interested in then and they don't know yet that they don't have to get involved in romantic/sexual/intimate relationships to stay clean.

There are several relationships that are imperative for early and on-going recovery: a relationship with a fellowship, a sponsor, a support group, the steps, a home group, a service position, consistent meeting attendance schedules, etc. Adding a romantic or sexual relationship at an early stage of recovery can shift the focus off of the recovery process and onto the new relationship. This can happen subtly without the people involved even knowing.

When someone, female or male gets involved in a romantic/intimate/sexual relationship with someone who is new or returning to NA it is a problem for both parties. It may not be evident immediately but ultimately the damage will be noticeable. Often overheard when a person with time is confronted about getting into a relationship with a returning newcomer, "Well they aren't a new newcomer, they have been clean before". So, is it a good idea for this person, who for whatever reason didn't stay clean in previous attempts to get involved in any relationship that shifts the focus off their own recovery? No, it is not.

People come to the rooms of Narcotics Anonymous and many have issues with interpersonal relationships. Many were raised in abusive homes or have some sort of abusive history. Some grew up people-pleasing to get by; others used manipulation to get what they needed. Some believe they need to engage in sexual activity to be loved, etc. Everyone has the right to feel sale to recover in the rooms of Narcotics Anonymous. We have a responsibility to ensure that the rooms are a safe place for people in any stage of recovery. When the rooms of Narcotics Anonymous are unsafe then addicts may not want to come to the rooms and they may die. We have a responsibility to make the rooms of Narcotics Anonymous as safe as possible. This may require that this behavior is confronted when it is seen.

Talking to people who are engaging in this behavior should be considered doing a twelfth step call, this should not be done alone. Some may believe that confronting someone with more than a one-on-one would be too intimidating. There is strength in numbers and we are more likely to act with spiritual principles if someone

else is there to support us. Some believe that this is an "outside issue" and we don't have the right to confront people engaging in this sort of behavior. We need to ensure that we are coming from a place of love and compassion when talking with someone about this sort of behavior. It says in our literature that, "we are each other's eyes and ears", this implies that it is acceptable, even advisable, to approach someone who is engaging in predatory behavior and explaining why this behavior is dangerous.

Predatory behavior can be brought up as a topic in recovery meetings. Anything that can affect an addict's life is relevant and can be shared about with a sponsor, peers or a support group.
