Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as time or location can be put in the GSR report box as well. GSR/Alt GSR must fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be tuned in before we discuss todays New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences or have closed: 11 Alive, Addict Salvation, Women of Freedom "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

According to page 17 of our Policy under becoming a voting group and scheduled meeting, "3. To maintain voting status, a group must not miss two consecutive ASC meetings. 4. Treasurer's Report:

The deposit for May income of \$3,347.04 was reduced by Bank of America by \$432 down to \$2,915.04. The bank correction notice indicated that the differences were in the currency count. When I received the notice last week, I contacted the Bank and initiated a Service Request, #1281-6562-88682, to dispute the difference. In the conversation with the bank, our currency amounts line by line were compared to the bank records and the differences were documented in the Bank's notes. The next step in the dispute process is the completion and signing of a form at a branch which I intend to do next Monday, June 10. The bank advised me that the dispute process would take approximately 5 days, so based on that time frame; we should have an answer the week ending June 15th.

Regional Proposal Number 1 - 05 - 13

The following is a proposal being submitted on the RSC floor May 19, 2013.

Motion #2-04-14-13: to submit the following proposal for inclusion to the CAR 2014 report at region in April.

Proposal: to place a moratorium of at least one full conference cycle, on funding and implementation of the service system project proposal, as well as any efforts to put into effect, a transition plan for implementation. This moratorium would be used by the Fellowship, to our current service structure, to learn about and explore alternative means of addressing the issues that led to the creation of the SSP by the 2008 world service conference participants, i.e. the apathy and indifference of our members in addition to finding ways to improve service delivery.

Intent: to provide the time and opportunity for our Fellowship to study all implications, pros and cons, contained in the SSP and how its implementation would affect groups, areas and regions locally, as this is the only way in which groups would be able to view and understand the SSP. To allow for continued growth of the global Fellowship using group conscience, a means by which the local groups, areas and regions gather the conscious of their members, as the primary method for service related decisions. Rationale: A true group conscious is a fully informed group conscience. It has become apparent that many members of the Fellowship, who have been involved in service efforts, have not been properly informed about the SSP. Many in our Fellowship do not even know of the SSPs existence. For our Fellowship to have such drastic changes decided and put in place at the next conference, would be a disservice. If groups, areas and regions determine they wish to implement portions of the SSP, there is nothing prohibiting them from doing so within our current service structure, therefore a moratorium would not hinder groups, areas or regions that are testing portions of the SSP. The traditions are the ties that bind us together, to disregard them has caused disunity. Final authority and autonomy resides within the NA groups. It does not serve our Fellowship to ignore or override our nonnegotiable Traditions. We will continue to learn, grow and evolve by respecting and following our Traditions. To do otherwise, would be to ignore or discount the hard-won experience that gave birth to the Traditions in the spiritual principles upon which this program rests.
