For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports typed you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as time or location can be put in the GSR report box as well. According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: Fresh Start, Primary Purpose "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. Fellowship Development: There are 2 more Behind the Walls meetings started at Marion Correctional. This is the first NA meeting there in 15 years. These meeting have been turned over to the local area and soon will be turned over to the inmates themselves and be self-sufficient. Gilbert went with the Bay Area PR Chair and their RCM to Westcare who runs a 18 month re-entry DOC facility where a Behind the Walls meeting will be started soon and literature has already been provided. Bridges of America meeting in Jacksonville has now been turned over to the First Coast Area and will be a self-sufficient meeting on Fridays at 6:00 PM. Joel attended FADAA (Fl Alcohol and Drug Abuse Assoc) Aug 7-9 in Orlando along with the PR Coordinator.

On May 30th the PR Coordinator participated in the second installment of the NA World Service PR Webinar series of meetings. There were members from across the country and a few from other countries as well. The forum allowed them to break into small groups and share their experience in PR.

The Technology Coordinator stated that they now have 512 members registered online at naflorida.org. There are currently 47 members registered from the Tampa Area. Remember to fill out your HRP form! We now have 971 meetings in BMLT (Basic Meeting Locator Toolbox) in 13 Areas. In a previous report I erroneously reported that all Areas in the Fl Region were using the BMLT which I found out was incorrect. There are 3 areas not using it (Space Coast, Treasure Coast and Big Bend but Big Bend has been communicating interest in implementing it.

Workgroups: Fellowship Development Inventory, Roles and Responsibilities of Workgroup Leaders and Resource Coordinators, HRP Refinement and Traditions Workbook Input. FRC Policy is completed with results turned over to the FRC Board

FRC: Since the last RSC the corporate secretary visited various law enforcement offices in an attempt to file charges against the former CFO. Hillsborough County informed them that they would not file a report since Polk County had already investigated the issue and closed the case. Public Relations:

The Public Relations subcommittee met today at 1:00pm. There were 12 members present and no new members. We opened the meeting with the Serenity Prayer.

There were 1400 copies of the meeting schedules printed this month and there were 6 changes to the following meetings: Hope Not Dope and a behind-the-walls meeting called Close Knit Recovery Group were added, Uptown NA on Friday and Women of Freedom were removed, and Live or Die was modified. Treasurer's Report:

For those that are new or did not know, each month I put ten copies of the Treasurer's report on the forms table for those that are interested in following along during my report later in this meeting.

There is also a new report this month that presents 2013 year to date income and expense including a column for each month of the year along with total year to date.

During the month of July, we had \$3,511 of income and expenses were \$3,766 so we had a net loss was \$255. Our prudent reserve is now \$2,341. We had two outstanding checks for a total of \$389; our ending bank balance was therefore \$2,730.

The net loss was caused primarily by a literature loss of \$573 for July (income of \$1,730 and costs of \$2,303). However, looking at Literature on year to date basis there is net income of \$115 (income was of \$15,510 and costs of \$15,396). Since literature income and expense and other line items can fluctuate greatly on a month to month basis, I will be including the year to date format in future Treasurer's reports in order for a better perspective on the financial results.

On a year to date basis, total income was \$27,691, total expense was \$27,297 and net income was \$394. Some reminders:

- We strongly encourage groups to submit their literature and donation payments in money orders or checks in group account names. Note that it is against policy to accept personal checks.
- Please complete your literature order form before you go to the Treasurer's desk to place your order. We do not have extra copies of Literature Order Forms.
- Remember to pick up your receipts; this is your record of your order.

Regarding the deposit reduction from Bank of America last May, last month a member asked about filing an FDIC "claim" with Bank of America. I contacted Ian Norkin of Bank of America regarding this claim, he said that he had not heard of this procedure, but he gave me his email address if that member or wanted to follow up directly with him on this FDIC procedure or any other questions regarding BofA's internal investigation of our deposit dispute.
