For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports typed you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as

time or location can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be turned in before we discuss todays New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: None this month. Our ending inventory was our lowest, \$1,377.53. This month's literature order was \$2,162.27 with a 6% discount. Also I received a flyer that on January 1, 2014, there is going to be a price increase such as Basic Text \$0.55, Just For Today \$0.90, Living Clean \$1.00.

So please let your home group members know. Also can we please give a big round of applause to our alt Jimmy, Mary, Liz, Danny, Witt, Kevin, Samantha, and Keena for their service and dedication.

RCM Report:

Regional Service Committee meets September 14 and 15 at the Plantation Resort in Crystal River.

Nature Coast will host the conference with a meeting and function on Saturday night.

RCM 1 is attending the Fellowship Development meeting on Saturday, while RCM 2 is present at ASC.

RCM 2 will bring the \$100 donation that Tampa Funcoast agreed to contribute toward the Service System Proposal workshop that Bay Area is hosting on September 21, 2013 at Terra Nova club on Central Ave in St. Petersburg.

At the Regional Service Conference in July, there was discussion during Fellowship Development about Concensus Based Decision Making and how Robert's Rules of Order translate to carrying the conscious of the areas on the regional floor.

RCM 2 presented to the ASC body a brochure explaining Consensus Based Decision Making taken from the Guide to Regional Service. A copy of this brochure will be attached to the ASC minutes.

RCM 2 will leave directly after the close of ASC business to represent Tampa Funcoast at the Regional Service Conference in Crystal River.

VICE CHAIR Report:

Good afternoon family, my name is Anna and I am an addict. I tried calling the city parks and rec in order to find out whom to make our form letter to and what it should say, I am now being given the run around and not told the same information. I can't seem to reach the person I originally spoke to, as there menu options have changed and I can't find her name and extension. No one I talk to seems to know what I am talking about though. So for now we are back to square one and cannot take money at parks for events. I will continue to try and see if I can reach the original person. I apologize for the inconvenience.

Stephen and I went to storage this past month as instructed. I have brought pictures to show. We did not inventory each item. To be honest, as Stephen said in the first place, the best thing to do is get rid of most of the junk in there and then inventory what we keep. The majority of stuff is junk, unfortunately. There are some decorations in there for activities, though some of it is becoming weather damaged. The storage unit is not climate controlled. As you will see by the pictures we are not using the full unit and once we get rid of what we don't need we will need even less space. We, Stephen and I, would like to put in a motion that we may use our discretion to clean out the unit and then move the storage to a climate-controlled facility. We would then come back with a full report of what is left in the unit. At a glance there is decorations, paper plates, utensils, coffee urns (3), a cabinet of old treasurer's reports and some minutes, and convention banners. There is sugar and creamer I am not sure is still good because I don't know if it's safe to keep out in the heat like it's been for months. Stephen and I got 2 quotes for storage units next to ASC. For a 5X5 unit at Public Storage on 30th near Bouganvillea it is \$45 a month plus insurance is approximately an additional \$11-\$15. For a 5X5 unit at People's Storage on 56th they are running a ½ price special for \$23, for the entire length we are there. Insurance would be additional, not sure of exact price. Both units are climate controlled. We are currently in a 10X10 non-climate controlled unit for \$76.48, which is being raised to \$102 on 10/1/13. I would like to put in a motion to move the unit to People's Storage at \$23 a month.

Learning Day committee met today and we have decided to move Learning Day to December. I am waiting for final confirmation from the church but most likely it will be 12/7/13 at Oak Grove Church at 6pm.

I received a money order from the last Secretary, Dan N, in the amount of \$33. This was the balance owed to the area from the money that is allotted for minute printing.

SUBCOMMITTEE REPORTS

Activities:

Helpline:

- 1. Good afternoon, we had 20 members at our subcommittee meeting and a couple of visitors that came to observe the subcommittee in operation and 4 new members.
- 2. As of September 1, 2013 we had 415 calls, using 1,266 minutes, and 6 messages for the preceding 30 days. The following is a summary of the calls we had over the past 30 days:

Note that we had an 18% decrease in calls and 21% decrease in minutes used from the same period a year ago. Note excerpt from September 2012 ASC minutes: We took 509 calls, using 1,618 minutes and we had 8 messages.

- 4. Ad-hoc committee and Learning Day rep gave their report of their respective progress. We selected Taryn as our new Learning Day rep. Ad-hoc committee is still gathering
- 5. It was previously discussed porting the helpline number to Line1 (our current answering and fowarding service provider) and eliminating cost of verizon (ie approx. \$30/month). We formed an Ad-hoc committee to research the effect of doing so (ie to include researching the costs associated with being listed in the phone directory, 411, and other such listings). The committee reported various points such as free listings that we have with various sources such as yellow pages, 411, and other Internet sources. Also it was reported other at-cost options that the subcommittee is considering and we expect in the upcoming months to make recommendation.
- 6. We experienced a situation and proposed a policy change that restricts Helpline members from handling money from Helpline callers.
- 7. Our next subcommittee meeting will be Monday, Oct 7 2013.

The Alternates Secretary works closely with the Secretary learning the duties of the office and taking over in case the Secretary is unable to attend ASC. The requirements for the office are the same as for ASC Secretary. The Alternate Secretary must attend ASC for three (3) months of the last twelve (12) months immediately prior to nomination. The Alternate Secretary is not a co-signer on the ASC bank account.

ASC TREASURER (OPEN) – Nominations in October and November with voting in December The qualifications of the ASC Treasurer:

Time, willingness and desire to serve.. At least 3 years of continuous abstinence from all drugs (cannot be waived). Active for at least one (1) year in the NA service structure. Basic knowledge of accounting procedures. Ability to lead, communicate and organize. Familiar with the ASC Policy, A Guide to Service in NA and the Twelve Traditions and Twelve Concepts.

The Alternate Treasurer works closely with the Treasurer, learning the duties of the office and taking over in case the Treasurer is unable to attend ASC. The requirements for the office of the Alternate Treasurer are the same as for the Treasurer. The Alternate Treasurer must attend ASC for 3 months of the last 12 months prior to nomination. Because the Alternate Treasurer might have to assume the position of the ASC Treasurer, the clean time requirement cannot be waived. The Alternate Treasurer is not a co-signer on the ASC bank account.

The qualifications of LDO are:

Willingness and desire to serve. 1 year of continuous abstinence from all drugs. Active for least 6 months in the NA service structure. Time and resources to do the job. Ability to lead, communicate and organize. Familiar with the Area Service Guidelines and Guide to Local Service.

ALTERNATE LITERATURE DISTRIBUTION OFFICER (OPEN) – Nominations in October and November with voting in December

The Alternate LDO works closely with the LDO learning the duties of the office and taking over in case the LDO is unable to attend ASC. The requirements for the office of the alternate LDO are the same as for LDO.

HOSPITALS & INSTITUTIONS (OPEN) – Nominations in October and November with voting in December The qualifications for H&I are:

- 1. 3 years abstinence from all drugs.
- 2. 2 years on H&I Subcommittee
- 3. 1 year service commitment, 2 term maximum
- 4. Facilitate all monthly scheduled meetings of the subcommittee.

- 5. Attend all H&I business meetings and new member orientations.
- 6. Keep discussion on topic, in an impartial manner.

- 3. The time and resources necessary to complete these duties.
- 4. Knowledge of the Twelve Traditions and Twelve Concepts of Narcotics Anonymous.

Previous experience as a working member of the Policy Subcommittee.

PUBLIC RELATIONS (OPEN) - Nominations in October and November with voting in December The qualifications for Public Relations are:

- 1. A minimum clean time requirement of one (1) year continuous abstinence from all drugs.
- 2. Previous experience of at least six (6) months in serving the Public Relations Subcommittee; preferably as a member of the Administrative Committee.
- 3. An understanding of the responsibilities of the office; administrative capabilities, and some knowledge in the field of Public Relations.

Treasurer's Report:

During the month of August, we had \$3,496 of income and expenses were \$2,837 so we had net income was \$658. Our prudent reserve is now \$2999.

The net income was due primarily by a literature income of \$685 for July (income of \$1,967 and costs of \$1.282.

On a year to date basis, total income was \$31,187, total expense was \$30,134 and net income was \$1,053. Year to date a literature income was \$17,477; expense was \$16,980 so net literature income was \$497. Since literature is by far our largest component of income and expense, if we have positive net income for literature, our overall Area income will most likely be positive as well.

Some reminders:

- We strongly encourage groups to submit their literature and donation payments in money orders or checks in group account names. Note that it is against policy to accept personal checks.
- Please complete your literature order form before you go to the Treasurer's desk to place your order. We do not have extra copies of Literature Order Forms.
- Remember to pick up your receipts; this is your record of your order.

CONSENSUS BASED DECISION MAKING


A working definition of consensus:

Consensus is a process by which a <u>common mind</u> of the meeting is sought about the <u>wisest way to move forward</u> on a particular issue at the time. It is derived from the Latin words <u>con</u> meaning "with" or "together with" and <u>sentir</u> meaning to "think" or "feel". So, "consensus" means to "think or feel together."

Consensus Based Decision Making is:

- A cooperative process for making decisions in which everyone consents to the decisions of the group
 - o Not everyone's first preference necessarily, but true consent
 - Decisions should reflect the integrated will of the whole group
 - Preserves the interests and integrity of all participants
- A problem-solving orientation for people who wish to work together
 - Not a process for determining whose ideas are best, but searching together for the best solution for the group
 - A questioning process, not the "okey-doke"
 - o The decision is in this room our job is to find it
 - o Have respect and enjoy creative conflict

Below is a diagram of the flow of conversation and decision making:



Discussion of the item: Discussion takes place here as well as in your home groups or over coffee. The item is discussed with the goal of identifying opinions and information on the topic at hand. The general direction of the group and potential proposals for action are often identified during the discussion.

Formation of a proposal: Based on the discussion, a formal decision proposal on the issue is presented to the group. It should be written down and projected so we're clear on what is being discussed,

Test for consensus/Straw poll: Thumbs up or down - to find degree of support and concerns of those opposed.

Identification and addressing of concerns: If consensus is not achieved, each dissenter presents his or her concerns on the proposal, potentially starting another round of discussion to address or clarify the concern.

Modification of the proposal: The proposal is amended, re-phrased in an attempt to address the concerns of the decision-makers. The process then returns to the call for consensus and the cycle is repeated until a satisfactory decision is made.

Call for consensus: The facilitator of the decision-making body calls for consensus on the proposal. Each member of the group usually must actively state their agreement with the proposal, often by using a hand gesture or raising a colored card, to avoid the group from interpreting silence or inaction as agreement. The decision reached by consensus takes into account the insights of all members. The process ensures that issues are fully aired and that all members feel they have been adequately heard. Decisions are taken not simply because one more than 50% of members are in favor of a proposal, but because all agree to a way forward. Some may feel that it's not necessarily their first option, but ALL can support it and commit themselves not to undermine the decision.

TRUE CONSENSUS is not the same as unanimity. We must be careful to recognize that real consensus arises out of real community, and often only through real tension as people express their insights with passion and integrily, and yet with respect for really hearing others' points of view.

Ideally,

- Concerns and reservations will be identified and addressed though the consensus based decision-making process,
- When the call for consensus on a proposal is made, you should ASSENT if you support the proposal, all things considered.
- Assent does not indicate that you may agree with every aspect of a proposal, but that you...
 - o Have heard the discussion
 - Have had a chance to participate in the process of finalizing the proposal
 - Are prepared to support the final proposal

Assent: This means that you support the proposal, all things considered. It may not mean that you are in agreement with every aspect, but that you have heard the discussion, have had a chance to participate in the process of finalizing the proposal, and are prepared to support the final proposal. Assent is signified by raising your Area's table card and remaining silent.

There are three degrees of dissent:

- Assent with Reservations I have some concerns that need to be heard.
- Stand Aside I have concerns but will not stop the group from moving forward.
- Block I have a serious issue with the proposal based on traditions or concepts and will not give my consent.

Assent with Reservations: Group members who are willing to let a motion pass but desire to register their concerns with the group may choose "assent with reservations." If there are significant reservations about a motion, the decision-making body may choose to modify or re-word the proposal. This option is not materially different from the assent option but is a way of giving addicts a place to stand when they do not need to object more strongly, but they want to note that they have reservations. Assent with Reservations by raising your hand and, when called on by the facilitator, simply saying "Assent with Reservations." The assumption is that the reservations have been heard already, and you are simply noting that you can support the proposal and continue to have these reservations.

Stand Aside: A "stand aside" may be registered by a group member who has a "scrious personal disagreement" with a proposal, but is willing to let the proposal pass. Although stand asides do not halt a proposal, it is often regarded as a strong "nay vote" and the concerns of group members standing aside are usually addressed by modifications to the proposal. Stand asides may also be registered by users who feel they are incapable of adequately understanding or participating in the proposal. Should there be a sizable number of Stand Asides (20% of the groups present), this will indicate a consensus too weak to adopt the proposal. The proposal is then either dropped or delegated to the maker of the proposal or an Ad Hoc Committee for reworking.

Block: Given that a proposal can be defeated by a sufficient number of Stand Asides, the Block should be an extremely rare step taken only when a participant honestly believes that one of the Traditions or Concepts is directly violated by this proposal or that some very fundamental moral position of the participant is violated. An addict who blocks must be able to articulate which Tradition or Concept or Spiritual principle fundamental to NA is violated by the proposal. Unanimity minus 20 % gives the ability of RCM's to actively block a decision.
