This is to insure that your group receives their minutes in a timely fashion. If you are a new Subcommittee Chair please be sure to update the contact sheet as well. For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports typed you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as time or location can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be turned in before we discuss todays New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$189.97 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: none "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

According to page 17 of our Policy under becoming a voting group and scheduled meeting, "3. To maintain voting status, a group must not miss two consecutive ASC meetings. 4. The group will be removed from the mailing list after missing 2 consecutive ASC meetings. 5. To re-establish voting status, a GSR (or alternate) must attend two consecutive ASC meetings." RCM Report:

We now have a regional newsletter. The purpose of the newsletter is to disseminate information and announcements from the region. At this time the newsletter is for information only and will not include articles such as stories, etc.

2 workgroups were completed...HRP Pool Refinement and Roles & Responsibilities of Workgroup Leaders and Resource Coordinators. As a result of the HRP Refinement project we now have a help wanted page. Members can now see the RSC positions / FD projects and volunteer for those opportunities directly.

Regarding the Traditions Workbook Workgroup – the RD was asked to present a Traditions Workbook Workshop, via NAWS guidelines, for input on this project and he agreed. The Region plans to put this workshop on at the next RSC in November.

Beginning January 1, 2014, there will be a 10% increase on all products from the WSO except the Basic Text which will only increase by 5%. Shipping rates will also increase.

The CAR will be out Nov 27 - We need to let the RSO know how many our Area wants to purchase at the next RSC or we will not be able to get them. The RSO will only be ordering what is pre-ordered and will not be purchasing any extras. Straw poll to change January RSC to include a C.A.R. Workshop. *Large support- no opposition*

Helpline:

- 1. Good afternoon, we had 20 members at our subcommittee meeting and a couple of visitors that came to observe the subcommittee in operation and 4 new members.
- 2. As of October 1, 2013 we had 320 calls, using 1,057 minutes, and 4 messages for the preceding 30 days. The following is a summary of the calls we had over the past 30 days:

Note that we had a 34% decrease in calls and 4% decrease in minutes used from the same period a year ago. Our average time on a call increased from 2.27 to 3.30 minutes/call. Note excerpt from October 2012 ASC minutes: We took 486 calls, using 1,101 minutes and we had 11 messages.

Treasurer's Report

During the month of September, we had \$3,423 of income and expenses were \$3,741 so we had a net loss of \$318. Our prudent reserve is now \$2,682.

The net loss was due to three payments that were either nonrecurring or higher than usual:

- Helpline rent of \$200 for the entire 2013
- Activity reimbursement for the \$130 deposit on the Memorial Day picnic
- Newsletter printing of \$404 for the special treatment center edition

On a year to date basis, total income was \$34,610, total expense was \$33,775 and net income was \$835. The key measure of year to date results is typically literature income and expense. Year to date literature income was \$19,620; expense was \$19,050 so literature had income of \$570

Some reminders:

- We strongly encourage groups to submit their literature and donation payments in money orders or checks in group account names. Note that it is against policy to accept personal checks.
