According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: none "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

According to page 17 of our Policy under becoming a voting group and scheduled meeting, "3. To maintain voting status, a group must not miss two consecutive ASC meetings. 4. Helpline:

- 1. Good afternoon, we had 15 members at our subcommittee meeting.
- 2. As of November 1, 2013 we had 399 calls, using 1,300 minutes, and 10 messages for the preceding 30 days. The following is a summary of the calls we had over the past 30 days:

Note that we had an approximately 20% decrease in calls and in minutes used from the same period a year ago. Our average time on a call remained at 3.25 minutes/call. Note excerpt from November 2012 ASC minutes: We took 499 calls, using 1,621 minutes and we had 9 messages.

Treasurer's Report: (Please see the attachment at the end of the minutes)

During the month of October, income was \$3,098 and expenses were \$4,431 so we had a net loss of \$1,333. Our prudent reserve is now \$1,349

The net loss was due to three payments that were either nonrecurring or higher than usual:

- Payment of \$1,000 for seed money to the FACNA committee.
- Literature income of \$1,503 and literature expense of \$2,092 for October, so there was net literature deficit of \$589.

Last year the 2011 FACNA convention donated \$5,565 back to Area, so the seed money we are donating now should considered an investment; not only from a recovery standpoint but also a financial standpoint as well. On a month to month basis, literature can swing hundreds of dollars from net loss to net income. On a year to date basis, literature income was \$21,124 and literature expense was \$21,143. That is a net deficit of only \$19.

Also on a year to date basis, total income was \$37,709, total expense was \$38,306 resulting in a net loss of \$597. Since literature is basically breaking even year to date, the net loss is driven primarily by the payment of the FACNA seed money.

Some reminders:

- We strongly encourage groups to submit their literature and donation payments in money orders or checks in group account names. Note that it is against policy to accept personal checks.
- Please complete your literature order form before you go to the Treasurer's desk to place your order. We do not have extra copies of Literature Order Forms.
- Remember to pick up your receipts; this is your record of your order.
