If you are a new Subcommittee Chair please be sure to update the contact sheet as well. For all members of the ASC who give reports that are included in the ASC monthly minutes I am requesting that you submit these reports typed you can submit the report on the day of area service by memory stick or you can email the report to me by the Wednesday following Area Service. Located on the table to my left, there are event flyers, literature order forms, GSR report forms, and meeting schedule change forms as well as a box for the GSR reports to be submitted. All meeting changes such as time or location can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be turned in before we discuss today's New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$182.74 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports. At today's GSR Orientation there were 0 in attendance. Please be sure to announce the GSR Orientation to all your groups.

According to page 17 of our Policy under removal from the meeting schedule, "If there has not been a representative of the group present for four (4) consecutive ASCs, a group will be removed from the Tampa Funcoast Meeting Schedule. While a group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a representative (not necessary a GSR) must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule"; therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to 4 or more absences: none "If a group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

According to page 17 of our Policy under becoming a voting group and scheduled meeting, "3. To maintain voting status, a group must not miss two consecutive ASC meetings. 4. LDO Report:

Hi Family, My name is Kim and I am an addict. Last month ending inventory was \$1273.12. This month's literature purchase was \$1526.37 with 6% discount. Also, since I went to pick-up our literature, our Area saved \$116.56 by not shipping our boxes UPS. However, they did charge is \$1.90 to me to pick-up the order.

Starting January our new prices go into effect. Our new order form will be available after January 1st, 2014. On our new form, the front will be a little different and the words 'New Order Form 2014' will be on the form. This will make it easier for our Treasurer to see it. Any old forms will not be accepted, this only hurts our Area, and the addict still suffering. Can we please give a big round of applause to Jimmy (Alt. LDO), Josh & Ron.

RCM Report:

Taken from the Dec 2013 Florida Region Newsletter:

"The South Florida Region has agreed to start using BMLT and host their meetings on our server. The possibility exists for the Alabama NW Florida region to do the same. With the addition of South Florida to the BMLT meeting map helplines, facilities, members, and visitors will be able to find meetings throughout the state even more effectively. We are one more step toward a statewide meeting list which was proposed at Fellowship Development.

The South Florida region would also like to start collaborating on shared services in the area of PR events. For example, if a PR event we normally attend that costs \$1000 would now cost us \$500, since we will be splitting the cost. I believe this information was passed on to us from our very own R.D. here in the Florida Region. More will be revealed at the next RSC. We are also collaborating with the Alabama NW Florida region getting them up and running with Behind the Walls. Trinidad and Tobago Area is a new member of the Florida Region joining Bermuda and The Bahamas Area.

Bridging the Gap Project - The purpose of the Bridging the Gap project is to provide a "Bridge" between Narcotics Anonymous meetings and people reentering their communities from in-patient treatment or incarceration. The project will be implemented in 2 stages. We are now in the first stage. During this time we will be gathering a list of volunteers with the willingness to be a "temporary contact". The temporary contact will help introduce addicts to Narcotics Anonymous. Being a temporary contact is basically a 2-3 week commitment. When enough volunteers are available throughout the Florida Region, the second stage will be to start matching temporary contacts with addicts re-entering their community. We are currently communicating with a re-entry facility in Tampa that has the willingness to make this service available to their residents. The tentative timeframe is late January or early February.

Conference Agenda Report - Every two years NA looks to the groups and interested members in order to provide input on items in the Conference Agenda Report. More than any other service report, the CAR is a conversation among the entire fellowship about the direction of NA as a whole. As the World Service Conference (WSC) Mission Statement points out, "The World Service Conference brings all elements of NA World Services together to further the common welfare of NA." At the 2014 WSC, we will address important issues such as our approach to local service efforts and the shape of the World Service Conference itself. These are not easy questions, and it's important to take the time we need to read through this Conference Agenda Report and think through the issues. Our Second Tradition makes it clear that in order for our collective conscience on matters to be in the right place, each of us has a responsibility to consult our own conscience."

We will be voting on the FRC Policy and By-Laws next month and we will be having a joint C.A.R Workshop with the Bay Area Saturday Jan 25 at "The Place" located at 5540 Park Blvd (56th & 72nd Ave) Pinellas Park, FL from 11-3 – FREE FOOD AND DRINKS!!! Helpline:

- 1. Good afternoon, we had 25 members at our subcommittee meeting.
- 2. As of December 1, 2013 we had 276 calls, using 660 minutes, and 5 messages for the preceding 30 days. The following is a summary of the calls we had over the past 30 days:

Note that we had an approximately 24% decrease in calls and in minutes used from the same period a year ago. Our average time on a call declined at 2.39 minutes/call. Note excerpt from December 2012 ASC minutes: We took 365 calls, using 962 minutes and we had 10 messages.

- 3. We discussed our agenda and plans for learning day; which was executed as planned.
- 4. We received a report from the ad-hoc committee looking into the porting of our number to Line 1; which resulted in more questions and follow-up questions.
- 5. It was brought up that many rehab and treatment facilities have out of date meeting information that they are distributing to members that are leaving those facilities. We discussed and developed an ad-hoc committee to develop a listing of facilities and other location and to develop a plan to distribute our meeting list on a regular basis.
- 6. We tabled discussions about the concept of a mobile response service to assist addicts to get to meetings. The ad-hoc committee requested more time in developing their recommendation.
- 7. We discussed the assignment given to Doug to create a flyer to assist groups for announcing about Helpline and 12 Step Volunteers.

Discussed was a member's participation in Area Services requirements for he/she to be nominated for a Chair or Co-chair position at the ASC body and/or Admin level. In your service, Terence B.

Public Relations:

The Public Relations subcommittee met today at 1:00pm. There were 6 members present and 1 new member. We opened the meeting with the Serenity Prayer.

There were 1400 copies of the meeting schedules printed this month and there was 1 change to the meeting Rise for Recovery and the meeting Recovery at Gilead was added. GSR's remember to please submit a meeting change request form by the end of area to get your changes into the next schedule.

The Tampa Funcoast Website had **3,061** unique visitors in November, which was a decrease of 477 visitors from the month of October. <u>Old Business</u>: First, we were in attendance at a very successful Unified Learning Day. Public Relations participated in a short skit to show unity between the difference subcommittees and it was followed by a presentation informing members about involvement in Public Relations. We look forward to participating again next year.

Next, we have finalized the FACNA Registration process, which will consist of a form on our website, which will be followed by a Paypal "Pay Now" button. The process still needs to be tested from end to end to make sure everything works properly.

Lastly, our next Poster Hanging event will be on January 18th at 10:45am. We will meet in Ybor City at the parking garage on the corner of 8th Ave. and 15th St.

Convention:

The FRCNA Support Committee met at the Rosen Shingle Creek Inn in Orlando. The Funcoast had 2 members in attendance. All subcommittees continued to work on the details for next years' convention. The theme for FRCNA 33 is "More Will Be Revealed." When registering, please remember that non-addict spouses and guests do NOT have to pay the registration fee. They simply need to check in with you and receive a guest badge. They only need to pay a registration fee if they want the registration package.

The Rosen Shingle Creek Inn is a beautiful facility with a friendly atmosphere. Our room rate for FRCNA 33 is \$125 / night but a \$25 voucher will be provided for each room night. The voucher can be used anywhere at the hotel (food, gift shop, room). For this rate you get a great room with a mini-fridge, coffee maker, and FREE wifi!! Please support the convention and stay at the host hotel. If you share 4/room and apply the \$25 voucher to the room rate, you would pay about \$30 - \$35 per person per night. Treasurer's Report: (Please see the attachment at the end of the minutes)

During the month of November, income was \$2,816 and expenses were \$3,658 so we had a net loss of \$842. Our prudent reserve is now \$507.

The net loss in November was due to the following:

- Payment of \$1,007 for Learning Day on December 7th.
- \$331 of secretary expense which paid the previous expenses of the alt-secretary also advanced \$210 to the new secretary.

On a year to date basis, total income was \$40,525, total expense was \$41,965 resulting in a net loss of year to date. Literature has income of \$391 year to date, so the net loss is due to:

- Payment of \$1,000 in FACNA seed money in October
- Learning Day expenses of \$1,007 in November

Note that both FACNA and Learning Day will contribute money back to Area. Some reminders:

- Beginning next month, you must use the new literature order form with the new prices; there will be copies at the Treasurer and the LDO tables.
- We strongly encourage groups to submit their literature and donation payments in money orders or checks in group account names. Note that it is against policy to accept personal checks.
- Remember to pick up your receipts; this is your record of your order.
