For all members of the ASC who give reports that are included in the ASC monthly minutes, I am requesting that you submit these reports typed. Located on the table in the back of the room, are event flyers, literature order forms, GSR report forms, and meeting schedule change forms; as well as a box for the GSR reports to be submitted. All meeting changes (such as time or location) can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be

turned in before we discuss today's New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$140.35 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports.

At today's GSR Orientation there were none in attendance. Please be sure to announce the GSR Orientation to all your groups.

According to page 2 of our Policy (under Removal From the Meeting Schedule), "If there has not been a representative of the Group present for four (4) consecutive ASCs, a Group will be removed from the Tampa Funcoast Meeting Schedule. While a Group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a group representative must attend two consecutive ASC meetings", i.e., must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule. Therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to four (4) or more absences:

Recovery in Riverview. Per Policy (under Reinstated to the Meeting Schedule), "If a Group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

According to page 2 of our Policy (under Becoming a Voting Group and Scheduled Meeting): 3. "To maintain voting status, a Group must not miss two (2) consecutive ASC meetings. 4. The Group will be removed from the mailing list after missing two (2) consecutive ASC meetings. 5. To re-establish voting status, a GSR (or Alternate) must attend two (2) consecutive ASC meetings." RCM Report: *Chair: Stephen P.* Florida Region Service Committee meeting will be at the Hilton Ocala on July 19-20. All are welcome and encouraged to attend Saturday's Fellowship Development and Area Support meetings, as well as Sunday's Regional Service Conference. Tampa Fun coast Area Service Committee provides rooms for interested members to attend.

VICE CHAIR Report: *Chair: Rick S.* We met today at 12pm. Learning Day will be from 6p to 10p on October 18th at Oak Grove Church. There are tee shirts on sale for \$10 for S, M, L, XL and \$15 for 2XL and 3XL. The deadline for the chili cook-off is October 1st, so please bring your contest entries through your home group. This month there was a miscommunication between the Public Relations subcommittee and the printer, which resulted in our skipping a month of printing. We talked about the process for printing the schedules and explored some other options, including the Regional printing service. I will be helping Public Relations. The literature order for this month was not ordered, but Ron will use the current supply on hand to fulfill orders. UPDATE: Ron and Jimmy will make the order in the coming week and get them out to home groups the best they can. We have planned an audit for next month before area at 10:30am. In Loving Service Rick S.

Question: Willie – Keeping the Faith 1&2 – where do we put recurring events? Answer: go to the Tampa Funcoast web site (tampa-na.org) and go to the drop down menu on the information page. Question: Shauna – Freedom From Pain – when is Learning Day? Answer: 10/18. Question: Billie – was a motion put in to obtain the money from ASC to buy the T-Shirts for Learning Day? Answer: It was already approved as part of the Admin Budget. Question: Andy – Grow or Go. Was consideration given to having Learning Day at FACNA? Answer: Yes. However, since the hotel has limited space and it was not cost effective it was decided to have Learning Day at a different time from FACNA.

SUBCOMMITTEE REPORTS

Activities: Chair: position open. Vice Chair: Alfred. There were 4 people in attendance at the meeting. A form was passed around to exchange contact information and sign in for attendance. Went over minutes from June including reviewing policy changes, items that needed to be taken care of and cancellation of the drive-in event. Went over rules and procedures of how subcommittees work, Activities primary purpose and voting were clarified by ASC Vice Chair. Area needs 2 months notice before an event can be held. Clarity given that there are requirements of a minimum of 4 events that need to be held each year. Those events are: Valentine's Day, Memorial Day, Halloween and New Year's Eve dances. The plan for the events and budgets are to be submitted in January for the year. Robert C. to clarify deposits and receipts for both Halloween and New Year's Eve dances. Need to amend minutes from June 1st meeting stating, "in the future CJ will at least take a picture with his phone," to "any subcommittee member paying for any expense will secure and deliver a receipt to area as soon as possible." Rick announced Ernest to be nominated as Activities Chair at next ASC. List of ideas were presented to give some variety to Activities and to try to promote unity (including trying to promote spiritual principles) which included: bingo, bowling sporting events, music events, treasure hunt, breakfast or brunch, karaoke, canoeing, fishing, bonfire, field/carnival day, music festival, camping, spiritual retreat, drive-in movie, mini golf tournament, skills day, community service events and combining with other committees. Committee members decided to concentrate on Halloween and New Year's Eve for now and decide on other events at a later time. Halloween planning was divided into: DJ-Paula, decorating: need budget prior to assigning, food: Alfred and asking fundraising if they would like to come,

facility: Robert. Halloween: reserved and paid for Friday, 10/31/14 (Treasurer has copy of contract). New Year's Eve: Jennifer paid the \$100 deposit for the American Legion, contract has been signed, facility rental is from 8pm to 1am on New Year's Eve, set up to begin at 6pm, Robert will pick up copy of contract and receipt for deposit. Contest: need assignment. Notes for next meeting: need to discuss traditions and mismanagement of funds as well as amount being paid to facilities; self supporting vs. fundraising in literature; needs vs. wants with new comers and the 5th tradition. Next meeting: 08/02/14.

Helpline: *Chair: Aris.* Good afternoon, we had 15 members at our subcommittee meeting. As of July 1, 2014 we had 406 calls, using 1,117 minutes, and 11 messages for the preceding 30 days. Note that calls and minutes used from last month remained flat. Our average time on a call was at 2.41 minutes/call. Note excerpt from July 2013 ASC minutes: We took 505 calls, using 1,252 minutes and we had 14 messages. We are urging members to get involved as 12-step volunteer by letting me or any other Helpline member know. We reassigned voice recording assignments to be completed by Chris M., Maria, and Yuly. We formed an ad-hoc committee to review our guidelines and to make recommendations. Began preparations for Learning Day to be held on Saturday, October 18th at the Oak Grove Church of God at 6830 N Habana Avenue where we intend to provide a presentation that will include 12 Step volunteer training. Next subcommittee meeting will be Monday, August 4, 2014. Note: the September meeting will be Monday, September 8, 2014 which is the second Monday since Sep 1, 2014 is Labor Day. In Loving Service. H&I: Chair: Wes. Emily, Vice Chair gave report. We met today at the new location on Busch Blvd. at noon. We opened with the serenity prayer; a member read the 12 concepts, and another stated H & I primary Purpose. There were 4 new attendees today and 5 out of 8 returning new members. With 22 members total in attendance. Secretaries Report: Cost of printing was \$14.02 for minutes and reports. Stressed for attendance purposes that all members sign in. Chair Report: This last month, we created a new H&I letterhead as the jail and some treatment centers require this to carry a presentation into the facility. Learning day is coming up in October 18th.if anyone else is interested we meet here at 10 am, before the business meeting. Nevertheless H and I will be represented this year and all Admin members will be a part of learning day. We have had some members recently leave the subcommittee. We would like to reiterate that a panel member commitment is six months. We are seeking help from NA members to step up to get involved with H&I to help to continue to carry the message into facilities where meeting attendance is restricted. Panel Coordinators report: I have been in contact with Ms. Carmen Burgos from the programs department with the jails. She has been provided with the list of volunteers. Everyone who would like to volunteer needs to go do an orientation. She would like everyone to go in a big group, but that may not be possible. They are willing to work with us to get every volunteer into the orientation. Concerns: Continued support. Panel leader reports were given. Elections: Christina - Acts Juv Residential; Will V - VA Hospital. New Business: Some facilities (including jails) have surveillance cameras. Some members were concerned about this, especially being an anonymous program. The cameras are used internally and are in place for our and their protection. The actual footage obtained is not shared anywhere. Everyone is aware that we can't change this. There was an orientation held after the business meeting, there were 15 in attendance, took approximately 15 minutes. For motion #20, we confirmed that this motion is out of order because this already in policy on page 14, item number 8. Thank you, and in your service, Terence B.

Question: Dave – Quest for Serenity. FACNA Motion intent was financial accountability. Shouldn't 20P mirror the responsibility of the subcommittee chair? Answer: All subcommittees submit financial report to the Treasurer. It's already a part of policy. If you want to have FACNA subcommittee report to ASC the Motion will need to be more specific. Point of Clarification: Aris. The confusion is in the misunderstanding of the organizational structure. Every subcommittee has a chair person and responsibilities within Policy. Convention reports to the ASC Body not the FACNA subcommittee chair. Point of Clarification: Steve – Convention – Chair already gives financial report monthly as well as provides bank statements. Question: Steven P – Motion is redundant – out of order – it's already in policy – does it preclude groups from voting on it? Answer: Yes. Question: Selena – why are we discussing the Motion during report? Answer: Good point. Question: Andy – another way to handle this is to take the general responsibilities in Policy and add individually to each subcommittee. Answer: I think it's redundant but if you want to suggest to Dave, then ok.

Public Relations: *Chair: Richard.* Opened meeting with Serenity Prayer. 7 members present. We discussed Learning Day. There will be a P.R. presentation. We talked about Poster Hanging Day which is 08/16/14 at 3333 W. Columbus Dr. at 9:30am. Come out and pass out flyers. We put a literature rack in Bridge of Hope. Answer: Embassy Suites. Question: Billy – Quest for Serenity – are there flyers for the upcoming event – flyers should be out 1 month before event – not a computer person so depend on flyers. Answer: sometimes we fall short; could use your help; do have everything online at least two months out though. Question: Kelly – why are we paying taxes? Answer: we are not tax exempt. Question: Robert –why did the expenses double from last year? Answer: hotel owned by Hilton and has to follow guideline of cost and expenses; in 2011 before Hilton owned the property, had more leeway. Bids were taken from several other hotels. Question: Andy – were bids taken from other hotels? Answer: bids at 14 different sites for different hotels around Tampa Area; Sheraton fell through. Results for June and 2014 year to date

During the month of June, income was \$3,574 and expenses were \$2,927 so we had a net income of \$647. Beginning prudent reserve was \$2,614 and ending prudent reserve is now \$3,261.

Year to date, net income is \$2,604 this year compared with a net loss of \$667 for the first six months of 2013.

Highlights

- Expenses for the most part were low in June
- We spent \$75 for Learning Day facility expense (one time) and there was \$288 for Newsletter printing which is an every other month expense.
- Year to date Literature income is \$11,867, year to date expense is \$12,178, so there a net loss in literature of \$248. Literature can swing between income and loss on a month to month basis; we monitor that amount because literature is the largest income and expense for the Area.
- Group donations were \$1,578 which a strong number. Thank you for that.
