GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be turned in before we discuss today's New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

Due to our policy on unexcused absences (pg. 13), the Activities chair is involuntarily resigned and the position will be opened for nominees to be taken next month. The Activities subcommittee meeting will happen as scheduled on the 1st Sunday of the month at the Meeting Place (address in meeting schedule). The Unified Learning Day planning meeting met at 10am today and we finalized the t-shirt logo and flyers. The food competition will be for best chili. Please submit contest entries to Rick (813) 966-1402 before October 1st.

SUBCOMMITTEE REPORTS

Activities: Chair: Absent. Report read by Alfred. Activities meeting was held on 06/01/14. Alfred, Robert, CJ, Rick, DeMarco and Lucy were in attendance. Old Business: CJ confirmed that the deposit are in place for the New Year's Eve and Halloween parties. Everyone agreed that we need receipts for proof. In the future, CJ will take a picture with his phone. Fundraising and events need to communicate together because fundraising is behind. We all agree that we should not worry about what the other Home Groups are doing. If there is not anything on the calendar we need to vote as a group body and claim the date, not discuss with other groups to make sure there is not something planned that we do not know about. It is their responsibility to get it on the calendar and we are promoting unity and fun for the entire area — which is important. There is no Treasurer for this group. It does not call for one but we do have an approved \$5,000 budget for the year from ASC. New Business: Rick is here to make sure we get clarification on policy for the Activities Committee. CJ stated that we were supposed to have a Memorial Day Picnic. After hearing from Alfred we have clarification on the intention of the sentence referring to the Activities Committee's commitment to host at least the four key holidays which are New Year's, Valentine's Day, Memorial Day and Halloween. The Activities Committee's job is to bring unity, not to raise money. Therefore, during conventions years we are supposed to set aside if the fundraising committee wants to plan something on those holidays. The policy is confusing and not clear so we made a motion to bring a proposed change of policy. We will be working with the ASC Vice Chair, Policy, and Convention to submit motions that make these responsibilities clearer.

Question: Jim – what is the policy on having a Treasurer for Activities? Answer: there currently is not a policy. Question: TJ – what are they doing during convention years? Answer: We are working on clarifying that.

Helpline: *Chair: Aris.* Good afternoon, we had 15 members at our subcommittee meeting. As of June 1, 2014 we had 428 calls, using 1,032 minutes, and 10 messages for the preceding 30 days. Note that we had an approximately 27% increase in calls while minutes used from last month remained flat. Our average time on a call was at 2.41 minutes/call. Note excerpt from last month ASC minutes: We took 338 calls, using 1,081 minutes and we had 5 messages. We are urging members to get involved as 12-step volunteer by letting me or any other Helpline member know. We reassigned voice recording assignments to be completed by Chris M., Maria, and Yuly. We formed an ad-hoc committee to review our guidelines and to make recommendations. Next subcommittee meeting will be Monday, July 7, 2014.

H&I: *Chair: Wes.* We met today at the new location on Busch Blvd. at noon. We opened with the serenity prayer. A member read the 12 concepts, And another stated H & I primary Purpose. There were 5 new attendees today. , and 2 out of 3 returning new members. With 23 members total in attendance. Secretaries Report: Cost of printing was 37.99 due to flyers printing and changes that are listed in the chair report. Stressed for attendance purposes that all members sign in. Chair Report: Looking at attendance as per the guidelines no member can miss 2 consecutive business meetings without a note explaining the absence to be voted on by the members of the subcommittee. A new h and I flyer was made, with the new address and guideline information on the flyer. The flyer was also uploaded to the Funcoast website to be added. We also asked that the old flyer be removed because of the location change, as well as the old book drive flyer, that should have been removed after the last book drive ended, Note that cost of printing was higher this month, to print the flyer and materials with the change of address, The criteria for the HSCO panels has been provided, and was posted on the Funcoast Facebook

Learning day is coming up in October 18th.if anyone else is interested we meet here at 10 am, before the business meeting. Nevertheless H and I will be represented this year and all Admin members will be a part of learning day. Panel Coordinators report. Called town and country multiple times left several messages with no return calls. Covered the jail criteria and started a list of members that we're interested in getting cleared. Concerns: Continued support. Panel leader reports were given. Elections: None. New Business. None. There was an orientation held after the business meeting. There was 10 in attendance, took approximately 15 minutes.

Newsletter: *Chair: Deborah.* Hello, my name is Deborah and I am an addict. The May/June issue of the newsletter has been printed and is being distributed. We printed 550 copies of a 8-page newsletter at the cost of \$288.90. The subcommittee had a teleconference today at 12:30 with 4 members present. We discussed the anniversary database clean up and how we shall proceed these next few weeks. We currently have 11 homegroups who have submitted their updated anniversary list. The homegroups are as follows: Grow or Go, Hope In Lutz, In The Middle, Keep The Faith, NA 180, New Tampa NA, Radical Recovery, The Sanctuary, Squeaky Clean, Together We Can, and TTNA. Results for May and 2014 year to date

During the month of May, income was \$3,209 and expenses were \$5,334 so we had a net loss of \$2,124. Beginning prudent reserve was \$4,738 and ending prudent reserve is now \$2,614.

Year to date, net income is \$1,957 this year compared with a net loss of \$(169) for the first five months of 2013.

Highlights

- There were several large, one-time expenses in May:
 - Region donation of \$798
 - Plumbing reimbursement of \$385 to TT Presbyterian
 - \$550 for Halloween party facility
 - \$133 for helpline rent though the end of this year.
- Year to date Literature is a negative \$541 (income of \$9,913 and expense of \$10454)
- On a more positive note, group donations were \$1,450 which a strong number. Thank you for that.

Disaster Preparedness, Response, and Recovery Plan – Coordination, Responsibilities, and Accountability

Proposal

To clarify in the Guide to Florida Regional Service (GFRS) the coordination of responsibilities and accountability related to the preparation, response, and recovery in the event of a disaster. This should be considered housekeeping for implementing **Proposal** #01-05-14 in which the coordination structure should be well-defined per Concept 1, responsibilities and a single point of accountability should be clearly delineated per Concept 5 along with the authority necessary to fulfill the responsibilities assigned as per Concept 3. Additionally, the Disaster Plan is provided as a source of experience, strength, and hope to Areas, Groups, and individual NA members **Rationale**

The Disaster Plan Workgroup was tasked with developing a Disaster Plan that would provide guidance in event of a disaster and continuity in Regional operations for collaboration, support, and problem resolution to the Areas.

The workgroup submitted **Proposal #01-05-14** which outlines the structure of coordination of responsibilities and accountability relating to Regional preparation and continuity of operations in the event of a disaster.

Current established Region, Administration Workgroup, and Fellowship Development Group purpose, responsibilities, and accountability are outlined as follows:

GFRS, Page 8, "The purpose of regional services is to support the Areas and Groups in their primary purpose ..."

GFRS, Page 8, The Vision Statement reads, "To better serve Areas, their member groups and individual addicts; to allow more widespread participation by more individual members; and to more fully utilize available human resources."

GFRS, Page 14, clearly identifies the members of Administration Workgroup and notes the Workgroup as the point of accountability for administrative processes, "This Group consists of the following: RSC Facilitator, RSC Co-Facilitator, RSC Secretary, RSC Alternate Secretary, RSC Treasurer, RSC Alternate Treasurer, Regional Delegate, Alternate Delegate, HRP Leader, Fellowship Development Leader and Co- Leader and Archivist. This body serves as a workgroup in addition to

the member's other duties to: Serve the administrative needs of the Region..." GFRS Page 36, The Fellowship Development Group's purpose, "The aim of the group is to further our primary purpose by developing and creating specific projects that will enable the region, its member areas and groups to better carry the NA message of recovery as well as enhance the growth and development of our fellowship."

Add the following bullet item to Duties of the Administration Workgroup - Page 14

• Executes the Disaster Preparedness, Response & Recovery Plan to ensure pre-disaster Regional resources are organized, accessible in the event of a natural or human caused disaster, and available during any required post-disaster recovery process.

Add the following bullet item to Duties of the FD Leader and Co-Leader - Page 33

• The FD Leader/Co-Leader update the Disaster Preparedness, Response, and Recovery Plan on an annual basis to incorporate new technologies, procedures, contact information, and any other changes.
