All meeting changes (such as time or location) can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be

turned in before we discuss today's New Business or you will have to wait until the next ASC meeting for the new motion to be read on the floor.

\$109.54 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports.

At today's GSR Orientation there were three in attendance. Please be sure to announce the GSR Orientation to all your groups.

According to page 2 of our Policy (under *Removal From the Meeting Schedule*), "If there has not been a representative of the Group present for four (4) consecutive ASCs, a Group will be removed from the Tampa Funcoast Meeting Schedule. While a Group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a group representative must attend two consecutive ASC meetings", i.e., must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule. Therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to four (4) or more absences: **Hope Not Dope.** Per Policy (under Reinstated to the Meeting Schedule), "If a Group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. Not one person got up, yet every day we hear of groups having problems. At Region they do the same thing. They give anyone the floor to bring up issues the areas are having. VICE CHAIR Report: *Chair: Rick S.*

The Admin body met today at 12:00pm. An audit at 10:30am revealed \$52.80 not accounted for. We are going to take an additional month to reconcile the difference. If it has not been reconciled by September ASC, we will ask the area to assist us in making a decision to correct it.

Unified Learning Day planning meeting met today at 10am. We collected \$445 from tee shirt sales, showing a profit of \$95. \$375 was deposited to the treasurer and \$50 was held to pay the refundable deposit for the venue. There are still about 30 tee shirts to be sold. We have had three entries for the chili cook-off from these home groups: Emergency Room, Uptown NA, and Hyde Park NA. If you wish to submit an entry for your home group, please contact Rick S. or bring your entry to the next ASC via your GSR. The deadline for contest entries is October 1st. ILS, Rick S.

Question: Willie – Keeping the Faith 1&2 – where do we put recurring events? Answer: go to the Tampa Funcoast web site (tampa-na.org) and go to the drop down menu on the information page. Question: Shauna (Freedom From Pain) When is Learning Day? Answer: 10/18. Question: Billie, Was a motion put in to obtain the money from ASC to buy the T-Shirts for Learning Day? Answer: It was already approved as part of the Admin Budget. Question: Andy (Grow or Go), was consideration given to having Learning Day at FACNA? Answer: Yes. However, since the hotel has limited space and it was not cost effective, it was decided to have Learning Day at a different time from FACNA.

SUBCOMMITTEE REPORTS

Activities: *Chair: position open. Vice Chair: Alfred.* Activities met at The Meeting Place at 3:00 p.m. on Sunday August 3rd. There were 10 people in attendance, which included 5 new members. We planned all the details for the upcoming Halloween dance which is scheduled for October 31, 2014. The event will open at 7:00 p.m. and will begin with a speaker, which is to be determined. The event will be held at the Wellswood Civic Center which is located at 4806 Wishart Blvd. The suggested donation for the event is \$5.00, but no addict will be turned away. There will be a contest for best costume, with prizes given to the best female, best male, best couple, and best child costumes. There will be a check request submitted today in the amount of \$595 which will cover expenses for the following: DJ, flyers, food, decorations, and prizes.

The New Year's Eve event has a location secured with a \$100 deposit. A total of \$649 will be required for the entire balance.

In closing, a policy change motion will be submitted today to handle the Activities and FACNA Fundraising policy discrepancies. ILS, Alfred

Helpline: *Chair: Aris.* Good afternoon, we had 20 members at our subcommittee meeting. As of August 1, 2014 we had 396 calls, using 926 minutes, and 16 messages for the preceding 30 days. Note that calls and minutes used from last month remained flat. Our average time on a call was at 3minutes/call. We are urging members to get involved as 12-step volunteer by letting me or any other Helpline member know. This is a critical issue as we only have 3 members serving in this role. We addressed another issue regarding various treatment facilities and the like that pass on meeting listings to their clients. As we noted that there are a number of calls we receive where the caller has gone to a meeting and no meeting was being conducted. To address this concern we have formed a listing of facilities that we will send updated meeting lists on a quarterly basis, at first. We formed an ad-hoc committee to review our guidelines and to make recommendations. Began preparations for Learning Day to be held on Saturday, October 18th at the Oak Grove Church of God at 6830 N Habana Avenue where we intend to provide a presentation that will include 12 Step volunteer training. Next subcommittee meeting will be Monday, September 8, 2014 which is the second Monday, since Sep 1, 2014 is Labor Day. ILS, Aris R.

H&I: *Chair: Wes.* We met today 8/9/2014 at Noon, on Busch Blvd. We opened with the Serenity Prayer, stated our primary purpose, and read the 12 concepts of service. There were 25 members in attendance. There were 0 new members, 9 returning new members from last month.

Secretaries report: cost of printing \$17.98, stressed importance of signing in on both attendance and orientation sheet as record of an individual being present. Also stressed importance of our policy which states all members should attend 3 orientations a year one every 4 months.

Admin Report: Still no communication with Town and Country Hospital. Myself as well as the PR chair Richard W. have not been able to contact them in efforts to get a literature rack in the hospital, or an H and I presentation in the facility. Our perception of the current situation is that they are not interested at this time (under new management), of having an NA presence in the facility. There was a concern brought to my attention about the overall need for panel members and new members to help carry panels. The panel members have also stated that with only one panel member (themselves), when a speaker cancels, (which happened several times this month), the panel is not able to be carried. What we need and are asking for is continued support and committed speakers, which most times is easier said than done, however after discussing with a few panel leaders, I believe today an idea brought up by one of our members may help in this situation. This will be open for discussion in new business.

Coordinator report: No changes no contacts from any facilities, the Hillsborough County jail and Town & Country Hospital included. Gave members the phone number today to set up clearance and orientation with the jails. Panel leader reports were given.

Concerns: VS panel members are still without clearance. Person able to conduct the renewal has not been available. Panel members will continue to attempt to get cleared for another month. Will revise status next month. Continued support and new panel members to help carry panels.

Old Business: Covered cameras used in facilities HCSO clearance as well as attendance and Learning Day.

New Business: Motion was made and passed to form an ad hoc committee to clarify any options we may have if only one H&I member is present, to ask the staff and residents to have an NA meeting instead of a presentation since only one person was in attendance.

Elections: Casey to Dacco R3 panel member.

Closed with Serenity Prayer at about 12:40 pm took a five minute break and held orientations after for about 20 minutes until 1:05 pm.

Convention: Chair: Steve C.

We meet on Aug. 2th, 2014, and opened the meeting with the Serenity prayer and the reading of the 12 Tradition. There was 13 voting members, and 1 new member. We discussed Registration items, cost of different vendors, and placed an order for

the Registration committee. We also reviewed the program layout and placed the order to start printing our programs. We then discussed the Merchandise items cost, and the numbers we need to order, also different outside vendors for the convention. We now have over 140 members registered for FCANA XXX. The online process works well, but since this is our first time doing online, there are many things we see that need improvement for future conventions.

We then discussed the next event which is the Masquerade Ball, and finding a location for the one after in September. The Hotel room night block is coming, and we still need your support in that area as well. We understand that our out of area guest will help with making that possible, and we are reaching out to them in all surrounding areas, also out of state. Lastly, there is a financial report from our last fundraiser and a copy of the bank checking account with this report. This month we paid for printing of the program (\$370), half of the total cost for all Registration items (\$571), and the balance of the cost to the Hotel for Masquerade Ball (\$672), totaling over \$1600 dollars. This has left us with a checking balance of \$1650 I believe.

One more thing, we (FACNA XXX) want to say Thank you to our Area, for voting yes on our motion for the cost of the Event insurance needed. We had asked for \$495, but the cost was lowered to \$409.61. Thank you never the less. There was a motion to close. Next meeting will be: Every Two weeks from the first Saturday, @ 10:00am. St. Paul's Lutheran Church. Please come out, all are welcome. ILS, Steve C.

Question (Andy): Is there a schedule of payments to make? Answer: \$4,000 deposit; 30% taxes and gratuity on top of hotel cost and the other \$6,000. Question (Choices): Where is the convention? Answer: Embassy Suites. Question: Billy (Quest for Serenity): Are there flyers for the upcoming event? Flyers should be out 1 month before event. Answer: sometimes we fall short, we could use your help. We do have everything online at least two months out though. Question (Kelly): Why are we paying taxes? Answer: we are not tax exempt. Question (Robert): Why did the expenses double from last year? Answer: hotel owned by Hilton and has to follow guideline of cost and expenses. In 2011 before Hilton owned the property, had more leeway; bids were taken from several other hotels. Question (Andy): Were bids taken from other hotels? Answer: Bids at 14 different sites for different hotels around Tampa Area; Sheraton fell through. *Point of Clarification* (re: posting event information): NA is not in any way affiliated with the social networking site, Facebook. *Point of Clarification*: No one maintaining area web site. That just happened this week. Rick S. will make sure events get updated on website calendar. Need help maintaining the Tampa Area website.

TREASURER'S REPORT: (See attachment at end of minutes)

For the month of July, we had income of \$3,008, expenses of \$4,300 and a net loss of \$1,293.

Our beginning prudent reserve was \$3,261 and our ending prudent reserve is \$1,968.

The results were driven by the July literature order of \$3,853. This compares with the average monthly literature order of \$1,988 over the past 18 months.

This will have to be explained by the LDO, however, we do know that there was no order in June, that there are backorders from June and apparently some stock was missing.

The following information is included in the Treasurer's Report for July 2014:

Results for July

During the month of July, income was \$3,008 and expenses were \$4,300 so we had a net loss of \$1,293. Beginning prudent reserve was \$3,261 and ending prudent reserve is now \$1,968.

Results for 2014 year to date

- Year to date income is \$27,973, expenses are \$26,661 and net income year to date is \$1,312 compared with a net income of \$412 for the first seven months of 2013.
- Expenses for seven months of \$26,661 compares with our total 12 month budget of \$65,094.
- Year to date Literature income is \$13,374 year to date expense is \$15,777, so there a net loss in literature of \$2,403.

Highlights

- Literature expense for July was \$3,853
 - There was no order in June; this is for the July order that is normally paid in August,
 - There are currently back orders from June and some or all of the medallions were missing due to change in the LDO position last month.
 - The bill was paid early due to the high dollar amount; we don't want surprises.
 - As basis of comparison, over the past 18 months, our average literature expense was \$1,988 and average literature income was \$2,031.

Suggestions and Reminders:

- Each month I put 10 copies of the Treasurer's report on the GSR table in the back of the room.
- GSR's; receive your minutes by Email We ask and encourage all groups to receive their minutes by Email rather than US Mail. There is a clip board on the GSR table with a listing of group contact information. Write "Email" in the far right column and write a legible email address next to that. Currently we mail 46 sets of minutes and are spending over \$2,000 a year on Secretary Expense.
 - I believe we cut that number in half.
- Thank you for those pay with a money order or group check, a reminder that it is against policy to accept personal checks.
- Remember to pick up your receipts; this is your record of your order.

<u>CON</u>: From group Happy Hour; read excerpt(s) from NA World Services Bulletin #21, The Generation of Funds (Fundraising) and the Seventh Tradition in Narcotics Anonymous:

"We strongly believe fundraising activities that divert us from the spiritual nature of our program are inappropriate and should not be encouraged within the fellowship. We believe that fundraising for the sake of fundraising is questionable, at best. There may be times, however, when a group or service committee finds itself in extraordinary financial constraints and begins to consider holding a fundraiser. At such times, we suggest that careful attention be given to support the group or service committee's actual needs? Are wants supplanting needs? Is the need for the fundraiser of such a nature that not holding it will result in our primary purpose going unfulfilled?" Final page 3: "The following general concepts have arisen from the experience of our fellowship, and we present them here as starting points for your consideration: 1. Fundraising activities at an NA meeting are not usually appropriate because they may detract from our primary purpose and can present an inaccurate impression of the NA message, especially in the eyes of the newcomer of the non-addict visitor."
