This is to insure that your group receives their minutes in a timely fashion. *Please also review the contact list and make changes accordingly*. If you are a new Subcommittee Chair please be sure to update the contact sheet as well. Note: Area Minutes are also available for download on the Tampa Funcoast website. For all members of the ASC who give reports that are included in the ASC monthly minutes, I am requesting that you submit these reports typed. Located on the table in the back of the room, are event flyers, literature order forms, GSR report forms, and meeting schedule change forms; as well as a box for the GSR reports to be submitted. All meeting changes (such as time or location) can be put in the GSR report box as well. GSR/Alt GSR **must** fill out a meeting schedule change form so that it can be updated on the meeting schedules and on our website. If you have a Motion Request form to turn in, it must be turned in before we discuss today's New Business or you will have to wait until the next ASC meeting for the new motion to

be read on the floor.

\$132.24 was spent on printing and mailing of Area Minutes, Literature Order Forms and GSR Reports.

At today's GSR Orientation there were none in attendance. Please be sure to announce the GSR Orientation to all your groups.

According to page 2 of our Policy (under *Removal From the Meeting Schedule*), "If there has not been a representative of the Group present for four (4) consecutive ASCs, a Group will be removed from the Tampa Funcoast Meeting Schedule. While a Group is not required to be a voting member of ASC to be placed on the Tampa Funcoast Meeting Schedule, a group representative must attend two consecutive ASC meetings", i.e., must be present for ASC roll call. This ensures that meetings that no longer exist are not placed on the schedule. Therefore, the following groups have been removed from the meeting schedule, attendance and the mailing of minutes due to four (4) or more absences: **NONE.** Per Policy (under Reinstated to the Meeting Schedule), "If a Group has been removed from the Tampa Funcoast Meeting Schedule, it may be placed back on the list by sending a representative to ASC. At ASC, they should notify the Public Relations and Helpline Chairperson that they would like to be added to the next publication of the schedule."

SUBCOMMITTEE REPORTS

Activities: Chair: position open. Vice Chair: Alfred. (Rick S. provided report)

Activities met on Sunday September 7th at 3pm. There were 7 members present. We finalized the food preparations and chose a speaker that will speak before the dance. The Halloween event will take place on October 31st at the Wellswood Civic Center. The setup will begin at 5pm, doors will open at 6:30pm, and the speaker starts at 7pm. We met September 8th, there were 10 members present. We took 331 calls for the month and used 879 minutes. We only had 6 messages. That means about 1 out of every 55 calls went to voicemail before it was answered, which is outstanding. Taryn and Jenna volunteered to get updated meeting schedules in a number of rehabs and detox facilities. Our next meeting is October 6th & we need support. ILS, Chris Mc

H&I: Chair: Wes

We met today, here, at 12:00 noon. We opened with the serenity prayer, read the 12 concepts, and stated H & I primary purpose. There were 5 new attendees today. And 3 returning new attendees. There were 29 members total in attendance. Secretary's report:

Make sure you sign in to be accounted as attending. No cost of printing. No problems to report.

Admin report:

I myself am going to have to leave Area service after giving this H & I report, due to a work commitment. If anyone at area would need to speak with me, please get with me directly after this or send me an email or call.

Members (both men and women) did turn their volunteer information into the HCSO jail system this month. Kurt will have more information in his coordinators report.

There was an Ad-hoc committee that formed and met on August 19th to discuss whether one person could change from holding an H & I presentation, to holding an NA meeting at the facility. In a situation where only one H & I member is present. After taking with my sponsor and other addicts reading literature, (and the H & I handbook that was published in 1986), the handbook says no less than 15 separate times: "No one should go into a facility alone". We must remember, I can't, we can. This is also clearly stated in ASC policy, as to not go into a presentation alone.

Coordinator report:

Women's raccoon Friday night, are looking to change the presentation time ahead 15 minutes because girls are always 15 minutes late.

Jail orientations are being held October @ 1pm. Men's slots are filled, women have 3 slots available for the female panel. Concerns:

The motion was reviewed according to our Policy and we answered the 5 questions on pg. 39.

- 3d) After analyzing the Con presented, the Policy subcommittee does not believe that having fundraisers for the FACNA Convention violates the 7th or any other Tradition, which includes the content of Service Bulletin #21.
- 3e) The impact of the policy change is that it allows us to be fully self-supporting and promotes unity within our Service committees. ILS, Rick S.

TREASURER'S REPORT: (See attachment at end of minutes)

The following information is included in the Treasurer's Report for Aug 2014:

Results for Aug

During the month of Aug, income was \$3,347 and expenses were \$2,413 so we had net income of \$934. Our beginning balance was \$1,968 and our ending balance is now \$2,902.

Results for 2014 year to date

- Year to date income is \$31,320, expenses are \$29,074 and net income year to date is \$2,246 compared with a net income of \$1,070 for the first eight months of 2013.
- Expenses for eight months of \$29,074 compares with our total 12 month budget of \$65,094.
- All subcommittees are within their budgets for 2014.

Highlights

- There was no Literature expense for August; we paid two months in July for \$3,853.
- No Literature expense is why we had net income in August rather than a loss, because there were several large, one-time expenses paid in August
- \$409 was paid for FACNA convention event insurance
- \$595 was paid to Activities for Halloween. We have now spent \$1, 145 on Halloween; previously \$550 was spent for the facility.

- \$385 for Learning Day T-Shirt, however, that was offset by \$375 of income from T-Shirt sales
- We also had RCM travel (\$189) and Newsletter printing (\$208) last month

- Each month I put 10 copies of the Treasurer's report on the GSR table in the back of the room.
- GSR's; receive your minutes by Email We encourage all groups to receive their minutes by Email rather than US Mail. On the GSR table in the back of the room, there is a Group contact listing. Write "Email" in the far right column and write a legible email address next to that. Currently we mail 46 sets of minutes and are spending over \$2,000 a year on Secretary Expense.
- Thank you for those pay with a money order or group check, a reminder that it is against policy to accept personal checks.

Old Business

Motion #22P Maker: Activities Second: Treasurer

Motion: To change policy under Activities and Convention committee guidelines to reflect "During the year before the Tampa Funcoast convention is held, the convention committee will conduct the Halloween and New Year's Eve dances as Funcoast convention fundraisers"

Intent: To provide clarity on conducting these events during the convention year.

Action: Take back to groups for questions, vote in October.

<u>CON</u>: From group Happy Hour; read excerpt(s) from NA World Services Bulletin #21, The Generation of Funds (Fundraising) and the Seventh Tradition in Narcotics Anonymous:

"We strongly believe fundraising activities that divert us from the spiritual nature of our program are inappropriate and should not be encouraged within the fellowship. We believe that fundraising for the sake of fundraising is questionable, at best. There may be times, however, when a group or service committee finds itself in extraordinary financial constraints and begins to consider holding a fundraiser. At such times, we suggest that careful attention be given to support the group or service committee's actual needs? Are wants supplanting needs? Is the need for the fundraiser of such a nature that not holding it will result in our primary purpose going unfulfilled?" Final page 3: "The following general concepts have arisen from the experience of our fellowship, and we present them here as starting points for your consideration: 1. Fundraising

activities at an NA meeting are not usually appropriate because they may detract from our primary purpose and can present an inaccurate impression of the NA message, especially in the eyes of the newcomer of the non-addict visitor."

New Business

Motion #23P Maker: How It Works Second: NA 180

Motion: Change to ASC Policy, Pg. 8, ASC Secretary, The. Responsibilities of the ASC Secretary, Para. 4 from "Type and distribute copies of the minutes and agenda to each GSR no later than 2 weeks following the ASC meeting; minutes may be emailed per GSR's request." to "Type and distribute by email only copies of the minutes and agenda to each GSR no later than 2 weeks following the ASC meeting." *Clarify: only email minutes, not print*

Tradition 5: Each group has but one primary purpose-to carry the message to the addict who still suffers. Concept 11: NA funds are to be used to further our primary purpose, and must be managed responsibly. "When NA members contribute service funds, they expect their money to be used carefully, and to be used for the SOLE PURPOSE of furthering our primary purpose" (12 Concepts of NA, 14).

Intent: To end unnecessary spending on printing and mailing of ASC minutes with 7th Tradition funds. **Action:** Take back to groups for questions, vote in November.

Question from Collette: what about those that don't have access to printer? Robert (maker) advised to rely on those in group that do have printer.

<u>Cons</u>: Collette - what about those with disability, do not have email address or printer. Joel - we might discourage the newcomer from service as they cannot afford. ASC asked Maker to withdraw, said no.

Elections

Activities Chair – *CLOSED* - Nominations to be taken in July and August with voting in September (Per Motion #18 this is for the 2015 position. Elected will hold position from election date through end of 2015).

Qualifications: Willingness and desire to serve. Two (2) years continuous abstinence from all drugs. Time and resources necessary to complete these duties. Familiar with subcommittee guidelines, ASC Policy, A guide to Service in NA, the Twelve Traditions and Twelve Concepts. Not hold any other ASC positions.

Nominee: Ernest H. Qualifications: 25 years clean, on the activities committee for 3 different ASCs, has a sponsor who has a sponsor, works steps, has sponsees, willing to serve and currently fundraising chair for the Convention Committee. **VOTED IN**

FRCNA Support Subcommittee Chair – *OPEN* (Per Policy, must be present for nomination and elections). **The qualifications for FRCNA Support Subcommittee Chair are:** 1 year abstinence from all drugs, the time and resources necessary to complete the duties of the position and a working knowledge of the Twelve Steps, Twelve Traditions and Twelve Concepts.

Nominee: MEREDITH – My name is Meredith D. and I am an addict. My clean date is March 15, 1991. I have a sponsor who has a sponsor. I have a working knowledge of the 12 steps, traditions, and concepts. I have enjoyed the Florida Regional Convention of Narcotics Anonymous, as a member of the Tampa Funcoast, since FRCNA 10. I have the willingness to serve as a representative of the area, to assist in putting on another great convention. I believe in giving back to my area and my fellowship, as I have a life today because of them.

ASC CHAIRPERSON (OPEN) – Nominations in October and November with voting in December The qualifications for ASC Chairperson:

Willingness and desire to serve. 2 years of continuous abstinence from all drugs. At least 1 year experience in the NA service structure. Time and resources to do the job. Ability to lead, communicate and organize.

ASC VICE CHAIRPERSON (OPEN) – Nominations in October and November with voting in December The qualifications for ASC Vice Chairperson:

Willingness and desire to serve. 2 years of continuous abstinence from all drugs. Active for at least six months in the Area NA service structure. Time and resources to do the job.

ASC SECRETARY (OPEN) - Nominations in October and November with voting in December The qualifications for ASC Secretary:

Willingness and desire to serve. At least 1 year of continuous abstinence from all drugs. Active for at least 6 months in the NA Service Structure. Time and resources to do the job. Ability to lead, coordinate and organize.

ASC ALTERNATE SECRETARY (OPEN) – Nominations in October and November with voting in December The qualifications for ASC Alternate Secretary:

The Alternate Secretary works closely with the Secretary learning the duties of the office and taking over in case the Secretary is unable to attend ASC. The requirements for the office are the same as for ASC Secretary. The Alternate Secretary must attend ASC for three (3) months of the last twelve (12) months immediately prior to nomination. The Alternate Secretary **is not a co-signer on the ASC bank account.**

$\label{eq:asc} \textbf{ASC TREASURER (OPEN)} - \textbf{Nominations in October and November with voting in December} \\ \textbf{The qualifications of the ASC Treasurer:}$

Time, willingness and desire to serve.. At least 3 years of continuous abstinence from all drugs (cannot be waived). Active for at least one (1) year in the NA service structure. Basic knowledge of accounting procedures. Ability to lead, communicate and organize. Familiar with the ASC Policy, A Guide to Service in NA and the Twelve Traditions and Twelve Concepts.

ASC ALTERNATE TREASURER (OPEN) – Nominations in October and November with voting in December The qualifications for ASC Alternate Treasurer:

The Alternate Treasurer works closely with the Treasurer, learning the duties of the office and taking over in case the Treasurer is unable to attend ASC. The requirements for the office of the Alternate Treasurer are the same as for the Treasurer. The Alternate Treasurer must attend ASC for 3 months of the last 12 months prior to nomination. Because the Alternate Treasurer might have to assume the position of the ASC Treasurer, the clean time requirement cannot be waived. The Alternate Treasurer is not a co-signer on the ASC bank account.

LITERATURE DISTRIBUTION OFFICER (OPEN) – Nominations in October and November with voting in Dec. The qualifications of LDO are:

Willingness and desire to serve. 1 year of continuous abstinence from all drugs. Active for least 6 months in the NA service structure. Time and resources to do the job. Ability to lead, communicate and organize. Familiar with the Area Service Guidelines and Guide to Local Service.

The qualifications of Alternate LDO are:

The Alternate LDO works closely with the LDO learning the duties of the office and taking over in case the LDO is unable to attend ASC. The requirements for the office of the alternate LDO are the same as for LDO.

HOSPITALS & INSTITUTIONS (OPEN) – Nominations in October and November with voting in December The qualifications for H&I are:

- 1. 3 years abstinence from all drugs.
- 2. 2 years on H&I Subcommittee
- 3. 1 year service commitment, 2 term maximum
- 4. Facilitate all monthly scheduled meetings of the subcommittee.
- 5. Attend all H&I business meetings and new member orientations.
- 6. Keep discussion on topic, in an impartial manner.
- 7. Prepare an agenda for each subcommittee meeting.
- 8. Ensure that the Traditions and Concepts are upheld.
- 9. Attend ASC meetings, submits a monthly written report of the subcommittees meetings, including a Treasurer's report as required.
- 10. Keep ASC informed of Subcommittee activities, needs and other relevant information.
- 11. Expedite action on motions deferred to the Subcommittee
- 12. Submit a year end written report at the Tampa Funcoast ASC.
- 13. Comply with all H&I Guidelines.

NEWSLETTER (OPEN) – Nominations in October and November with voting in December The qualifications for Newsletter are:
