Quorum is defined as the number of voting Groups required to be present at ASC. The procedure the ASC Secretary uses to establish quorum is outlined below.

1. Take attendance.
2. Determine the number of Groups present that have not missed more than two consecutive meetings.
3. Quorum for ASC is more than half the number of eligible voting Groups (e.g. - 60 Groups: quorum is 31; - 61 Groups: quorum is still 31.
4. Official quorum must be reached before voting and elections can take place.
5. Groups must be present for both roll calls scheduled on the agenda. If either roll call is missed, they are considered absent from ASC.

qualifications for Convention Chair are: A minimum clean time requirement of three (3) years continuous abstinence from all drugs. Previous experience of at least six (6) months in serving the Public Relations Subcommittee; preferably as a member of the Administrative Committee. An understanding of the responsibilities of the office; administrative capabilities, and some knowledge in the field of Public Relations.

ASC CHAIRPERSON (OPEN) – Nominations in October and November with voting in December. The

qualifications for ASC Chairperson: Willingness and desire to serve. 2 years of continuous abstinence from all drugs. At least 1 year experience in the NA service structure. Time and resources to do the job. Ability to lead, communicate and organize.

Nominee: *Mary S. Qualifications: Willingness and desire. Chair for the past year. I have the willingness and desire to serve. 9 years of continuous abstinence from all drugs. 5 years of experience in the NA service structure – 6 years as a HG Secretary, 2 years as a GSR, and 2 years as Alternate Secretary for ASC, 3 years as Secretary for ASC. Active for at least one (1) year in the NA service structure. Basic knowledge of accounting procedures. Ability to lead, communicate and organize. Familiar with the ASC Policy, A Guide to Service in NA and the Twelve Traditions and Twelve Concepts.

Nominee: *Terence B. Hello, my name is Terence B. and I'm 7 years clean, currently Treasurer, previously served as Alternate Treasurer, I've already had some service commitment at Area level.*

ASC ALTERNATE TREASURER (OPEN) – Nominations in October and November with voting in

December. The qualifications for ASC Alternate Treasurer: The Alternate Treasurer works closely with the Treasurer, learning the duties of the office and taking over in case the Treasurer is unable to attend ASC. The requirements for the office of the Alternate Treasurer are the same as for the Treasurer. The Alternate Treasurer must attend ASC for 3 months of the last 12 months prior to nomination. Because the Alternate Treasurer might have to assume the position of the ASC Treasurer, the clean time requirement cannot be waived. The Alternate Treasurer is not a co-signer on the ASC bank account.

Nominee: *Aida. Qualifications: Hi family, I am an addict, my name is Aida W. I am in service, as your current Alternate Treasurer. I have been clean for 22 years. I have a sponsor, who has a sponsor. I have a working knowledge of the 12 steps, Traditions, and Concepts. I practice the spiritual principles in my life, to the best of my ability. I have held every position at my home group. I have been in service as: Registration Chair for the Women's Retreat (08), FRCNA Rep. for 2 years, H&I for 2 years. Helpline (2*

yrs), I used to carry a beeper? I have the willingness, desire, and personal accounting experience necessary with skills to fill this position. In Loving Service, Aida W.

ASC SECRETARY (OPEN) - Nominations in October and November with voting in December. The qualifications for ASC Secretary: Willingness and desire to serve. At least 1 year of continuous abstinence from all drugs. Active for at least 6 months in the NA Service Structure. Time and resources to do the job. Ability to lead, coordinate and organize.

***Nominee:** Raj. Qualification: 4 years clean. Served as Secretary for ASC in Cleveland, OH 1993-1998. Have a Sponsor. Works Steps. Acting panel leader DACCO H&I for past 15 months.*

LITERATURE DISTRIBUTION OFFICER (OPEN) – Nominations in October and November with voting in December. The qualifications of LDO are: Willingness and desire to serve. 1 year of continuous abstinence from all drugs. Active for at least 6 months in the NA service structure. Time and resources to do the job. Ability to lead, communicate and organize. Familiar with the Area Service Guidelines and Guide to Local Service.

ALTERNATE LITERATURE DISTRIBUTION OFFICER (OPEN) – Nominations in October and November with voting in December. The qualifications of Alternate LDO are: The Alternate LDO works closely with the LDO learning the duties of the office and taking over in case the LDO is unable to attend ASC. The requirements for the office of the alternate LDO are the same as for LDO.

ACTIVITIES CHAIR (OPEN) - Nominations in October and November with voting in December. The qualifications of Activities Chair are: Willingness and desire to serve. Two (2) years continuous abstinence from all drugs. Time and resources necessary to complete these duties. Familiar with subcommittee guidelines, ASC Policy, A guide to Service in NA, the Twelve Traditions and Twelve Concepts. Not hold any other ASC positions.

***Nominee:** Rachal B. Qualifications: 12 years clean. Have a sponsor. Do service work. On WSUWH committee. Coordinate campout for homegroup. Have the time and willingness.*

NEWSLETTER (OPEN) – Nominations in October and November with voting in December. The qualifications for Newsletter are: Two (2) years clean time. Elected by The Tampa Funcoast Area Service Committee and must adhere to their guidelines regarding elected Officers. Have an understanding of the responsibilities of the office, administrative capabilities and some knowledge in the editing, production and distribution of a newsletter.

POLICY (OPEN) – Nominations in October and November with voting in December. The qualifications for Policy are: Willingness and desire to serve. Two (2) years continuous abstinence from all drugs. The time and resources necessary to complete these duties. Knowledge of the Twelve Traditions and Twelve Concepts of Narcotics Anonymous. Previous experience as a working member of the Policy Subcommittee.

Nominee: *Eddie I Qualifications: Eddie I. Clean date: 6/28/88, Currently Policy Chair, involved in service since I was 6 months clean, served all commitments but one to full term. I was Chair, H&I Chair, Secretary. I have a Home Group. I will do the job to the best of my ability.*

PUBLIC RELATIONS (OPEN) – Nominations in October and November with voting in December. The qualifications for Public Relations are: A minimum clean time requirement of one (1) year continuous abstinence from all drugs. Previous experience of at least six (6) months in serving the Public Relations Subcommittee; preferably as a member of the Administrative Committee. An understanding of the responsibilities of the office; administrative capabilities, and some knowledge in the field of Public Relations.

The following nominations have been made for the Administrative Committee positions that were open in 2017, prior to the election cycle opening again; these positions are now closed for the 2017 term and will be voted on in November so that these persons may serve the term for December. If a new nominee is given for the 2018 term, they will have to be nominated, again for the 2018 term and voted on, again, in December.

ASC VICE CHAIRPERSON (CLOSED) – The qualifications for ASC Vice Chairperson: Willingness and desire to serve. 2 years of continuous abstinence from all drugs. Active for at least six months in the Area NA service structure. Time and resources to do the job.

Proposal: Tie RSC stipend to standard IRS rates.

Rationale: The IRS sets maximum rates for travel. The rate adjusts each calendar year. The 2017 rate is \$189 per day, which includes the hotel, taxes, tolls, and mileage. The 2016 rate was \$185. Although mileage rates have gone down, room rates are \$30-\$50 more per night than they were when the \$150 stipend was set. Increasing the stipend has come up several times on the floor, but no proposal has been made to date.

Financial impact: For the rest of 2017, this would increase the stipend \$39, up from \$150. The current fixed rate of

\$150 is no longer adequate to cover room and travel for one day. Tying the stipend to the IRS rate allows adjustments without having to change the GTFRS each year.

GTFRS: Each member of the Administration Workgroup and Resource Coordinators shall receive a stipend of one day at the standard IRS rate.
