Step Five: "We admitted to God, to ourselves, and to another human being the exact nature of our wrongs."

I've heard lots of people in the rooms say that the fourth step was by far the toughest step for them to complete, because it was the hardest one for them to start. They were afraid of going back down the path their lives had taken, fearing the act of revisiting these memories would cause them to feel the pain all over again. It takes commitment and courage to stand in the face of such fear and continue on. Working the previous steps with a sponsor helps to prepare us for this monumental undertaking. This is only the beginning of our new life, we will need to call on the foundation of our recovery many times in the course of our journey through the steps, so we must build it strong. For me it was the fifth step that caused fear and anguish. I could write and write on my fourth step, digging deeper into my past, but the thoughts of

How It Works (a Funcoast series on the steps and traditions) sharing my findings with another human being and the God of my understanding scared me to the point of inactivity. The fifth step also asks me to identify my true nature, to reveal this to another. This is where the rubber hits the road, this is where it gets real! In the steps I'm asked many times to put my faith in a Higher Power, stepping out on faith is what our program is built on. In the fifth step I have an opportunity to practice my newly found faith, and I do so by working this step even though I'm unsure of the results. Working step five is not simply a reading of our fourth step, we draw upon the faith we gained in the second step when we share this step aloud, facing up to the exact nature of our wrongs. We find that by hearing ourselves make these admissions we get out of the denial that our disease thrives on. We made a decision in the third step to turn over our will and our lives to our Higher Power, this step gives us a chance to put that decision into action, courageously trusting the relationship we are building with the God of our understanding.


> This step can be a humbling experience, we may find that we are not the "larger than life" personality we thought we were. Most of our actions were dictated by our disease and have been exaggerated in our minds. Our need to feel good about our past actions may have given us

a distorted view of ourselves. After working this step we may finally see ourselves as we truly are, and begin to enjoy just being that person. By no means is this, or any other one of the steps a quick fix, our need for instant gratification can cause us to expect all of our problems to just disappear after we work a few steps. In the course of our journey through the steps we strive to awaken our spirit and grow into a new way to live. We now choose to not have our feelings deadened and we must face these feelings. We no longer need to be numbed to get through our day, we have a program that is introducing us to spiritual principles, practicing these principles is how we grow. With the new friends we have in recovery and in the meetings, we are seeing others doing the impossible...and we can do it too. Now that we are beginning to see our true nature, and our trust in the program is strengthening, we go on to the sixth step. -Joe Addict

Tradition Five: "Each group has but one primary purpose—to carry the message to the addict who still suffers." Tradition Six: "An NA group ought never endorse, finance, or lend the NA name to any related facility or outside enterprise, lest problems of money, property, or prestige divert us from our primary purpose."

Dear Family:

I must first say how grateful I am that someone has asked me to share my experience, strength and hope regarding Traditions 5 & 6. Tradition 5 clearly states that our number one purpose is to carry a clear message of recovery. Not any message, but the message of NA. We can do this in our own way. Sometimes it's through passion and conviction; other times it's through peace. It can even be given through times of sadness. Every addict, in the rooms, in society, deserves to hear, "The message is hope and the promise if freedom, that an addict, any addict, can stop using, lose the desire to use, and find a new way to live."

When working Tradition 6 for the first time from the "Guiding Principles –The Spirit of Our Traditions," it was revealed to me that the "things" we use to avoid feeling are the things that feed our self-obsession.My experience and understanding of this tradition is to not suggest or endorse (in a meeting) a specific detox or treatment facility. Outside of the rooms, I can make a suggestions, through my own experience, which one or where. NA is, by itself and through its members, enough to sufficiently carry the message. As I require "stuff," it can end up diverting me. Those things are good, but they are not recovery. I am just another recovering addict, not better or worse than anyone in the rooms. I am grateful to be alive and be of service,

## Ask An Addict

What is this Area Service thing I keep hearing so much about?

"The Area Service **Committee (ASC)** The area committee is the primary means by which the services of a local NA community are administered. The area committee is composed of group service representatives, administrative officers (chairperson, vice chairperson, secretary, treasurer), subcommittee chairpersons, and the area's regional committee members. The area committee elects its own officers, subcommittee chairpersons, and RCMs." (Guide to Local Services in Narcotics Anonymous, vii)

"Area service committees are ultimately responsible to the groups they serve. Narcotics Anonymous groups send group service representatives (GSRs) to serve on the area committee. While still maintaining final responsibility and authority for area services, they invest enough delegated authority in their GSRs—and through them, in the area committee-for the necessary work to get done. NA groups also send money to the area committee, money needed to coordinate panels, maintain phonelines, and conduct public information activities. Through their contributions of money and manpower, the groups exercise both their responsibility and their authority for NA services." (Guide to Local **Services in Narcotics** Anonymous, p. 46)

"There are three groups of participants in most area service committees: GSRs and their alternates, administrative officers, and subcommittee chairpersons. The Seventh **Concept for NA Service** says that, "All members of a service body bear substantial responsibility for that body's decisions and should be allowed to fully participate in its decision-making processes." Group service representatives provide a "grass roots" perspective to the area decisionmaking process, helping ensure that the committee's feet are planted firmly on the ground. Administrative officers and subcommittee chairpersons also bear substantial responsibility for the fulfillment of area services. Their ongoing

growth and experience in carrying out their duties is an invaluable resource to the area The Area Service Committee as it develops and expresses its group conscience. We ought never allow a base of valuable experience to be created without utilizing it to the fullest. Each area is responsible to create its own decisionmaking plan. In doing so, area committees should carefully consider the Seventh Concept." (Guide to Local Services in Narcotics Anonymous. p. 46-47)
