Our trusted volunteers this month was Frank M, our alt ( Robert F ) and myself

Please note the following information :

It has been brought to my attention that there is no spot on the order form to order 18 months or the Infinitely Medallions.

Please remember that the first column on the order form is for Spanish ITEMS only, If the box is xxxxx out it is not available.

I recently figured out if you order a custom laser medallion... There is an additional shipping charge of \$ 7.60 from the Regional Service Office to ship this item back to our area from the vendor once they receive it. This happens because we order the week after area on a Monday, usually to allow time to get the order shipped, go through it.. and allow some time for back orders from RSO to be shipped in time before the next ASC. The vendor will not ship direct to the LDO. This cost is not actually listed on the RSO forms. The RSO told me that the person that created that software for the order form long ago, actually locked it and is no longer with the RSO for quite a while so they cannot edit the form.

GSR's please REMEMBER it is YOUR responsibility to communicate through the home group to know if you have a back order to pick up... not ours..

We will be asking to put a motion on the floor to put items not picked up by the Fourth month, the item will be put back into ASC inventory.
