E. New business:

1. Discuss motion given to me by Joel: To include in area policy, all requirements and qualifications for ASC Subcommittee chairs. Intent: ensure that nominees are qualified and possess the skills and abilities to be an effective leader. See concept 4: Effective leadership is highly valued in Narcotics Anonymous. Leadership qualities should be carefully considered when selecting trusted servants.

2. p. 9 under Responsibilities of ASC Treasurer - #7 reads to send funds to Region at the END of the months listed. (Change "at the end" to "prior to the start of ASC") These are the months that Region meets. Historically, the amount of the donation for those months was known by the RCM so that (s)he could put the amount in his/her Regional report. It seems to make more sense to me to calculate the amount to send at the end of the previous month so that the amount being sent to Region could be announced at ASC during the months that Region meets and the RCM would know the amount for their report.

3. Same page #10 requires the treasurer to provide the ASC bank statements for the minutes. Not sure when we stopped doing this but we need to decide as a body if we want to keep this in. If so, sensitive bank data would need to be blacked out. Motion to remove line #10.

I have looked into finding a different bank for our Convention account to avoid the \$17 monthly fee discussed last month but as we do not have an active SunBiz account we are not able to switch banks. I need to let you know that there have been some fraudulent charges on the Convention account, and I am working with last year's convention chair to get those charges reversed and a new debit card issued.
