- 1. Discuss motion given to me by Joel: To include in area policy, all requirements and qualifications for ASC Subcommittee chairs. Intent: ensure that nominees are qualified and possess the skills and abilities to be an effective leader. See concept 4: Effective leadership is highly valued in Narcotics Anonymous. Leadership qualities should be carefully considered when selecting trusted servants.
- 2. p. 9 under Responsibilities of ASC Treasurer #7 reads to send funds to Region at the END of the months listed. (Change "at the end" to "prior to the start of ASC") These are the months that Region meets. Historically, the amount of the donation for those months was known by the RCM so that (s)he could put the amount in his/her Regional report. It seems to make more sense to me to calculate the amount to send at the end of the previous month so that the amount being sent to Region could be announced at ASC during the months that Region meets and the RCM would know the amount for their report.
- 3. Same page #10 requires the treasurer to provide the ASC bank statements for the minutes. Not sure when we stopped doing this but we need to decide as a body if we want to keep this in. If so, sensitive bank data would need to be blacked out. Motion to remove line #10.
- 4. Same page #11 requires the treasurer to provide monthly bill statements to Helpline. Since the Treasurer pays this, not Helpline, this does not make sense. Motion to remove. Line #11.
- 5. Discuss retention policy for old documents. Make motion to add to policy a retention period of 5 years for all documents. At year's end, dispose all

This is partly because we started last ASC already \$49.90 into prudent reserve and had the additional expenses of paying the annual fee for our PO box (\$168) and spending \$100 to support the CAR and Concepts Workshops. I also added a summary box to break down what was donated for literature and what the LDO spent as well as how our total group donations compared to the month's expenditures.
