A representative of Recovery Central advised us that the meeting is still meeting even though they have not had a GSR present at ASC for, four months per today's ASC. Convention:

We want to thank everyone for your support at our Valentine's Day Dance, Saturday, 02/12/22. We especially want to thank the Women Stand United with Hope Retreat Committee! Because of those ladies it was a huge success! We had approximately 95-100 people in attendance. It was a great turn out. With admission, Merchandise Sale, Registrations, Beverage sale and the Basket Raffle minus the rental of the Church, we made \$716. We want to thank the WSUWH Retreat Committee for donating all the proceeds to our FACNA convention. On Sunday, 02/13/22 we had a Super Bowl Party at Wellswood Civic Center. It was a very modest turn out. Unfortunately, because we paid \$800 for the rental of the Wellswood Civic Center, we lost money on this event. So, we net \$116 for the weekend with these two events.

We have \$5,402 in the bank which includes \$2,000 Prudent Reserve and Hotel Alba has not deducted their \$1,500. We reimbursed Area \$600 for the Super Bowl Party. We have use of funds available \$1,902. Our next payment to Hotel Alba is due March 30 in the amount of \$2,000.

We currently have approximately 114 people registered. The registration is \$35. We are asking everyone to please announce the FACNA convention in your Homegroups and to please register!

Hospitals & Institutions:

Hello I am Frank and I am an addict

This I reached out to two facilities this past month.

One we currently have a panel at and another we once carried two panels to before the pandemic.

The current panel concern was attendance at our presentations there. We had a week with no attendees.

The facility stated the current group of clients were not really interested in either NA or AA but she would encourage her staff to hopefully get clients involved in the presentation moving forward.

I know it's hard for HnI members to see very little attendance. I served on a panel that had 60 participants dwindle to two or three. As much as we want to carry the message

to everyone at the facility it still very important to carry our experience with NA to the few who do show up.

The other facility had no present date to drop COVID restrictions or resume an HnI panel at their two locations.

However, the subcommittee made contact to assure we are on board to bring presentation back in when needed.

I received the 50 dollar check that I requested in January this past area and made a donation to St Paul's Lutheran church that following week. We had no attendees in person or online for the February makeup/ alternative meeting.

I cannot stress the need for recovering addicts to give back and join the HnI subcommittee. Once a member if an addict could attend a HnI panel every other week, this would be very helpful. Many on the subcommittee are carrying or attending panels every week for a long time now. They really could use some help. Panel members or General HnI members can step up and chair HnI presentations and give panel leaders or other members a break to maybe attend a meeting on the night they regularly commit to an HnI panel.

If you have the willingness to speak at a HnI presentation get with the HnI panel leaders who would love to hear from you. Share your positive experience with Narcotics Anonymous to Newcomers.

Today we had our business meeting, with several in attendance with one newcomer to HnI.

Carried 39 out 40 of presentations.

One panel was missed do to the panel leaders change in work schedule that day.

We have a request for a Thursday panel at a facility we already have one at on Tuesday.

Jail panels are in the works with starting their requirements and participation process all over again. Finger printing has been added to requirements. So we do need more support.
