I like to thank everyone for their service to H&I subcommittee this past month. Once again I have had a busy month. I however did not make the quarterly ASC committee meeting do to a family issue that came up last month.

Riverside Recovery reached out to Yuly. The CEO was wondering if the H&I subcommittee could in addition to bring literature to our panel each week fill a NA literature rack there or would they need to purchase the pamphlets.

I let them know we have a limited budget for literature and if they need more than we currently bring to the facility they would need to purchase it thru NA world services or the Florida Region NA offices. I also suggested they encourage clients to seek NA IP pamphlets free for the taking at local NA meets they are taken too.

I been busy recruiting new and current H&I members to support the need of an additional River Oaks panel Thursday nights.

In addition to River Oaks Plant City White Sands is requesting a second panel. Possibly a Return to Friday or a Sunday evening in addition to our current Wednesday panel.

There were no attendees to the make-up meeting the Thursday after our Saturday business meeting. This made two months in a row no attendees. I was going to suggest discontinuing the make-up meeting but I met two addicts interested in H&I and the Thursday business meeting. I put a request in with ASC treasurer for our quarterly make up meeting rent donation for \$50 payable to: St Paul's Lutheran Church Tampa FI. I did receive that check.

Tim from the Recovery Coast in Pasco county reached out to me. He would like me to attend a learning day in their area and explain H&I subcommittee accomplishments and guidelines here in the Funcoast for 10 minutes. He would appreciate if myself or another trusted servant could attend and speak. He was not interested in any panel members speaking but they are welcomed to attend. The event will be a Saturday May 21st at Sun West Park, Hudson FL. I have no willingness to speak at another area's learning day far away from my home. I work late Friday nights into Saturday morning hours. I also have an annual garage sale at my home that Saturday. If our area was having the learning day I would have the willingness and be committed to the event.

With all this need for additional H&I panels I cannot convey enough we need support to carry the message to newcomers in treatment. Please get involved in H&I and suggest to the people that you sponsor the importance of having a service commitment. We have two very accommodating business meetings in person and online to become a member. Panels are all over the county with three online currently. Just committing to a panel every other week will help us drastically.
