I was in contact with Laura P. From Acts Sandra Prince Intermediate Care. They requested an HnI panel last Month. The facility is a 90 to 120 day, residential treatment facility. They are very flexible on weekdays and evening time for the presentation and will work on our availability. Hopefully by next month we can get some HnI members willing to support this new panel. Its located on 131st StreetTampa.

Pete our panel leader informed me they did not meet July 27th do to a covid outbreak. When they showed up on August 3rd, they had no idea about our presentation.
