FACNA 36 final financial report on the convention:

On 09/30/22, we went into the convention with 322 paid registrations and 128 Banquet Tickets sold. Prior to Hurricane IAN, we had 109 room reservations at Hotel Alba and 10 room reservations at the Embassy Suite our overflow hotel. Unfortunately, because of the Hurricane we ended up with 77 rooms. Members who came to the convention without a room reservation and wanted a room, Hotel Alba honored the group rate.

We currently have \$9,072 in the bank, which includes our \$2,000 prudent reserve. Total income made from the convention – which includes Registrations,

Merchandise, Fundraising Events, Raffle, the Auction: \$39,552

Total expenses for the convention – which includes the Hotel, Programming, Registrations Supplies, Rental for Fundraising Events, Rent, Bank Fees: \$32,480 Profit made from Convention is: \$7,072

We will pay Area back the funds donated to the convention \$3,605 and we will Donate to Area \$2.926.

We had our primary H&I business meeting today the second Saturday of the month at 12 noon before Area Service. This meeting is also hybrid meeting ID 86411195160, p/w 007510 Our chair nominee withdrew from the elected position.

*This month we planned to distributed NA books from our book drive and hard cover books given back to us from the county jail.

33 soft cover basic text and 2 soft cover It works How and Why were slated to the County Jail Drug Program. 2 JFT's will be used for our weekly panels at the jail. Cove Behavioral (formerly DACCO) will receive 12 hardcover Basic text and 12 hard cover It Works How n Why books, a JFT mediation book. They will be distributed between men's and women's programs at Cove.

Also ACTS detox will receive 5 Softcover Basic text. A small number of hardcover basic text 5th editions were received from the jail but as a subcommittee we could not distribute per NAWS guidelines. They were given to an NA member and given to the woman's program at the Tampa Salvation Army treatment facility. They were in great need of NA literature.

Once again I like to thank the Funcoast NA groups and Individuals that donated NA books for those who needed them in treatment here in Hillsborough County.

Unfortunately, the Hillsborough county jail officials do not want the NA books. (Our past jail coordinator offered to replace the hardcover books given to us from the jail. This is why we had our book drive.)

So we are reaching out to individuals and large donors to see if they want the donated books back or if its ok to donate to other treatment facilities including neighboring county jails. I personally reached out to Bay Area and Heartland H&I subcommittees about their county jail NA book needs. (Bay Area had no need) Heartland had a need for Polk county jails we voted to sending the books to that county jail.

As of now we will distribute Books to other facilities also. If Funcoast Area meetings or individuals would like their donated books returned get with me to facilitate. However, they are benefiting those in Jails just not in Hillsborough County.

ATC treatment Facility reached out this month requesting a weekly H&I presentation as well as another informative presentation about Narcotics Anonymous. This makes yet another facility wanting a H&I presentation with still no support from the Funcoast Area. Unfortunately, this does not put our local NA Funcoast Area in a positive light as a viable source of recovery to local Treatment Centers seeking H&I presentations. In addition, people in treatment do not hear about Narcotics Anonymous or testimony from our local recovering addict members on how we recover here in the Funcoast.

On a positive note we have had many Funcoast NA members reach out to support the county jail H&I presentations. Past panel jail participants and new to H&I altogether. But to participate in the County Jail panels you must be an active member of H&I with serious commitment to serve for long-term. The background checks and training of limited members to participate in jail presentations is a important commitment to hold. Ramona acting Jail coordinator must verify to the facility total commitment for those seeking access and willingness to participate in these county jail presentations.

Today we planned to nominate a trusted H&I member who has been part of the subcommittee for several years for chair. However, they removed themselves from voting do to work conflicts fulfilling the commitment of H&I chair. While I complete my responsibilities as H&I chair at the end of the year I still will be part of the subcommittee and support it anyway I can. As stated when I took the chair commitment last year I will not seek a 2nd term.

1) We want no change from 2022 Budget

- 2) We used less than ¼ of our budget in 2022 because Smaller meetings, online meetings and detox has not met for approximately 2 months.
- 3) Our budget is based on going back in-person to all facilities, future presentations that have been requested from facilities not yet meeting. Current presentations increased attendance.
- 4) If we do add more H&I presentation we will need these funds to support meetings with more literature.
- 5) We want excessive funds in our budget to cover all new facilities if that were to happen.
- 6) Better to have a higher budget and use less of it than have a lower budget and presentations go without NA literature when budgeted funds run out.
- 7) Appropriating funds for Zoom meetings is not necessary. Those online presentations may go back to in person. Or if the generosity of donated funds for the platform ends we can use area's zoom account to facilitate our H&I presentations and business meetings online.
- 8) Pre COVID we were using a majority of this budgeted amount and can easily return with more presentations.
