#### **Budget Details**

- 1) We want no change from 2022 Budget
- 2) We used less than ¼ of our budget in 2022 because Smaller meetings, online meetings and detox has not met for approximately 2 months.
- 3) Our budget is based on going back in-person to all facilities, future presentations that have been requested from facilities not yet meeting. Current presentations increased attendance.
- 4) If we do add more H&I presentation we will need these funds to support meetings with more literature.
- 5) We want excessive funds in our budget to cover all new facilities if that were to happen.
- 6) Better to have a higher budget and use less of it than have a lower budget and presentations go without NA literature when budgeted funds run out.
- 7) Appropriating funds for Zoom meetings is not necessary. Those online presentations may go back to in person. Or if the generosity of donated funds for the platform ends we can use area's zoom account to facilitate our H&I presentations and business meetings online.
- 8) Pre COVID we were using a majority of this budgeted amount and can easily return with more presentations.
