Fellowship Development

Topic for the afternoon was Potential Project Idea to create or revise literature that reiterates that. Marijuana(Cannabis products) are a drug such as is stated in our reading that "Alcohol is a drug."

Our brainstorming session was first a large group discussion about the generalities of the logistics about rewriting our literature and whether or not the idea is already covered in our literature. A portion of the discussion was about where this would fit into our literature, i.e. revision of existing literature for Worldwide consumption or a local resource. After large group discussion, small roundtable discussions were engaged and because there was no detailed result outlined in the Project Idea the roundtables were brainstorming sessions where development of the idea was the goal.

Decision about whether or not a Work Group with a project goal was needed or desired at this time resulted in consensus that this was a topic that was not going to go away and the discussion should be ongoing throughout our entire fellowship. There were many experiences and opinions offered at each of the six roundtables and the presentations varied from creating new literature to simply continuing to keep the discussion going. There was unanimous consensus and the conscience of the participants that there was not going to be one single answer or solution to this issue. The nuances of the discussion were so varied it would be impossible to not leave anything out. Therefore we ask that for additional information on the initiation of this discussion at our RSC please ask any of the participants for additional information and participate in future discussions about this topic at the Area Support Group at our RSC and anywhere else. The FD team suggested that a period of time be utilized during area support sessions moving forward be utilized to continue this discussion. The most important contributing factor to furthering this discussion is for all to be open minded and not dismiss any member's opinion or idea no matter the amount of experience or clean time as every viewpoint is important and pertinent as our fellowship continues to change and grow. What applies to one demographic of our fellowship may not apply to another and we must always look at the ramifications and benefits to the whole, not specific demographics.

Hospitals & Institutions

We met today at noon with approximately 20 in attendance. We had two new attendees and four returning for their second business meeting. We carried 26 out of 30 presentations last month. We missed one presentation because of sickness and the other three because of facility problems. I missed reported last month that we had the 5 women required to start the women's jail presentations. We only had 4 and still only have 4 women that have completed their requirements. We have two males with their PV numbers. The jails require 5 persons per sex to be able to start bringing in meetings. We are getting close but still need people willing and able to go into the jail. So if you or know of someone with at least 1 year clean, 5 years off of a felony, and 3 years off a misdemeanor, does not have any violent charges or is a sex offender, please consider helping. We met with the staff of Coves men and ACTS to give them information about NA and H&I. Pluss we inquired about starting another presentation in their facilities. We voted to start another presentation at ACT detox on Sundays at 7PM and at ACT Amathis on Saturdays at 1PM. We hope to start these this month. Note; Cove Mens on Fridays at 6PM has been put on hold because of a Covid outbreak until further notice. We plan to contact them to see if we can bring our presentation via Zoom.
