Area subcommittee had 8 in attendance

- A few members brought up concerns about disruptive behavior within the admin body and the vice chair, me, wrote this letter and read it during the meeting and will be reading it on the area floor:

Vice Chair Letter:

I'd like to make this committee and service body aware of some concerns I am having since joining as Vice Chair.

NA teaches us that in order to recover we must apply the spiritual principals embedded in our steps, traditions, and concepts in all our affairs. These principles teach us how to treat one another and ourselves and this admin body and service committee is included under "all our affair."

Since joining 3 months ago, I've noticed that committee members and the admin body as a whole tolerates and enables disruptive behavior from one or more members. I've even participated in some of this very behavior and I think we can do better. It is the admin committee responsibility as a whole to maintain an atmosphere of recovery that is safe, productive, and fosters mutual respect, it does not fall on just one member.

Some examples I've seen of this are:

- Interruptions while other members are speaking and speaking over and louder than others

- Undermining side comments that erode at trust, unity and safety to speak up and ensure every members voice is heard, especially the lone one
- Aggressive behavior towards others- at one time one member offering to "take this outside" during a heated argument
- The Policy chair brought a grievance about one admin member's treatment and the following month while reviewing what we as a committee will do to resolve disruptive behavior, several members called the grievance "stupid", a "waste of time"- and essentially mocked our 10th concepts- this severely erodes the guiding traditions, concepts and principles we are supposed to be upholding ourselves to.
- Several times one member has openly expressed personal opinions about others input or perspective
- There seems to be a strong desire to be understood rather than trying to understand

Equally, I've also witnessed several occasions where the above behavior did not occur and we were guided more by respect, cooperation, unity, trust, collaboration and open mindedness that are instilled in our traditions, concepts and principles. So far what I've seen has been unattractive. I believe we can do better.

Listen, I want to serve, I'm new to area and have the willingness, experience and time but I I've worked too hard on my recovery to willing put myself in atmosphere that hinders my spirit rather than allow it to flourish. We don't have to treat others this way anymore now that we have a recovery program to guide our actions and relationships ships with others.

If we continue to treat each other this way I don't think the Vice Chair position is going to be a fit for me. I'd like to propose this service body commit to doing an inventory to talk through a new way of operating. At this time I will not be acclimating into the Chair role come January 2024. I will continue to serve as vice chair through the end of my term December 2023 and then make my decision to run again for Chair during the November elections based on how I see things changing.

Instructions for an Area to Form a Corporation and Obtain Tax Exempt

Status

If your Area wants to obtain tax-exempt status from the IRS and be

included in the FRSO Group Determination for tax-exempt or not-for-profit status:

- 1. The Area will need to form a Florida Not-for-Profit Corporation. The Area forms an ad-hoc committee to determine the Corporation's Board of Directors, herein referred to as "BOD". The BOD will hold responsibility for compliance with federal and state laws. The purpose of this ad-hoc is to:
- a. Determine by spiritual inventory and/or cost-benefit analysis whether legal compliance is necessary and/or financially warranted.
 - b. Propose the corporation's name
- c. Recommend the number of BOD members. There is a legal minimum of one (1) but no maximum number, however an odd number is recommended for voting purposes.
- d. Decide whether the members come from the Area Service Committee or from the membership at large.

Suggestion – choose four Officers (Chair, Vice Chair, Secretary, Treasurer) and three non-officers to form a board of seven members.

- 2. The Area ad-hoc committee completes the Articles of Incorporation and submit it via U.S. mail to the State of Florida. Do not use online filing!!

 Request a certified copy and a Certificate of Status. Total Fee is \$87.50.
- 3. The Area ad-hoc committee prepares the Bylaws.
- 4. Once the certified copy of the Articles of Incorporation is returned to the Area from the State of FLA, the Area's BOD is legally official and the Area's ad-hoc committee can be disbanded.
- 5. The Area BOD has the Bylaws approved by the ASC.
- 6. The Area BOD applies for a Federal Employer Identification Number (EIN), using Form SS-4, located on IRS website. Go to www.irs.gov and on the left menu, under "Online Services", click on "Apply for an Employer Identification Number (EIN) Online".
- 7. The Area BOD can now open a checking account under the corporate name and the new EIN. Suggestion Once the Area is incorporated, the area and should close all accounts under its 'old' Id and open a new account using the corporate name and EIN.

 8. If your Area wishes to be included in the Group Exemption under the Florida Regional
- 8. If your Area wishes to be included in the Group Exemption under the Florida Regiona Service Office, herein referred to as "FRSO", submit the following to the FRSO by the July RSC meeting:

your completed FRSO Group Exemption Request Form, and a copy of your Area's BOD certified Articles and Bylaws. Your fiscal year end must be the same as the FRSO (May 31).

The Area BOD will receive a copy of the Letter of Group Determination from the FRSO.

9. Annually, the Area BOD, its Treasurer, or the Area's Treasurer determines and complies with the IRS filing requirements and submits either Form 990, Form 990-EZ, or Form 990-N. IRS filing requirements can be found in IRS publication, Instructions for Form 990, located on the IRS website, www.irs.gov.

The Area will be required, by the FRSO, to submit a copy of the Area's annual Form 990

IRS filing to the FRSO, to continue being included in the FRSO's Group Exemption. What is It?

- Section of Tax Code for a non-profit, charitable organization.
- 501c3s are company's recognized by the IRS.
- Effectively, it means we will legally be considered to be a non-profit.

Aren't We Already a Non-Profit

- In the eyes of the law, no we are not.
- NAWS, Florida Region, etc, these are all groups that have applied for and received 501c3 status.
 However, every NA group/area/etc is independent. Because we don't fall under a traditional corporate-style umbrella, we do not automatically receive the legal benefits that other parts of the service structure have applied for.
- Despite the fact that we do not make a profit, in the eyes of the law Funcoast ASC is taking in and distributing large sums of money without paying taxes or even filing financial disclosures.
- We're also selling merchandise (key tags, books, etc) without collecting sales taxes.

Risks of Not Becoming 501c3

- Risk of audits and lawsuits from federal and state tax authorities, since we are not currently filing or paying taxes.
- Florida in particular has a state law that can assign felony charges for failing to register properly.

- Damage to image: this would be a terrible thing to see NA in the news over being sued by the IRS.

Benefits

- Exemption from paying income taxes.
- Exemption from sales taxes.
- We will be an official legal entity, which can help with applying for liability insurance and other related things.
- We will be in compliance with state and federal laws.
- When applying for things like an insurance policy, we will be able to have this policy under the group's name rather than an individual member.

Legal Requirements

- Fill out Form 990, which details our finances, for the IRS.
- Have a "board of directors".
 - Similar in concept to ASC Officers, but it is not required to be the same people. These will be the people legally recognized as the leaders of the organization, however.

Best Way to Become 501c3

- Florida Region has the ability to take us under their umbrella.
- We fill out a quick form, pay a fee (I believe \$800, but I'm not certain of this), and we officially become an extension of them.
 - Joel knows the specific details of how to do it.

Spiritual Principles

- It's the law! Non-profit entities are required to register.
- It would violate the principles of honesty and integrity to simply choose not to register.

Process for Becoming a 501c3 Under Florida Region

- Full details can be found at: http://naflorida.org/tax-exempt-filing/
- They need this done by November to send everything in.
- Summary of the required steps (Again, full version is at the link above)
 - Decide if we want to do this.
 - Recommended to create an Ad Hoc committee to get this process started. Which we kind of already have.
 - Determine who the Board of Directors (BOD) will be.
 - No requirement on how many, but it should be an odd number.
 - File Articles of Incorporation to become an official non-profit company.
 - RSO provides a link for the form.
 - Filing fee is \$87.50.
 - This is the only specific fee indicated on the Florida Region website.
 - Gets approved by the State of Florida.
 - Create official bylaws for the company.
 - There's a template on the RSO website.
 - We can have them be our policy, or include parts of policy, or make it however we want.
 - ASC BOD applies for a federal ID from the IRS website.
 - ASC BOD applies for an Employer Identification Number from the IRS website.
 - ASC BOD can now open a checking account under the corporation using the federal ID.
 - It is recommended that the ASC close all old accounts and use the new account exclusively.
 - Send a request to the RSO to be included as a tax exempt group under its umbrella.
 - Include a copy of the certified Articles of Incorporation and the Bylaws.
 - Our fiscal year must become in sync with the RSO's (ending May 31).
 - Annually, the ASC Treasurer determines its IRS filing and fills out Form 990.
 - This form must be submitted to the RSO as well to remain under their group exemption.

Additional Details

- Board members will have a fiduciary responsibility to the organization.
 - Duty of Care = Board member must actively participate in the operations of the organization.
 - Duty of Loyalty = Board member must operate in the interest of the organization and not promote a personal or any other agenda.
 - Duty of Obedience = Board member must comply with all state and federal laws, as well as any bylaws or rules specified in the organizations operating documents.
- Individual groups will not automatically be able to exercise the tax exempt status of the area.
