FRSC met on September 15-17, 2023 in Orlando.

• Tampa Funcoast Area RCMs 1&2 were in attendance.

Area Support (Saturday)

Topics Discussed:

- Overcoming barriers to unity in our fellowship including but not limited to geography, cultural, race, virtual platform meetings.
- Dealing with members not respecting rules and boundaries.
- Areas obtaining 501c3 status and the ongoing responsibilities associated with it.
- ASC vacancies and area level trusted servants resigning abruptly.
- Members not supporting the fellowship financially.
- Service bodies and Homegroups using "group chats" and addressing issues such as disruptive behaviors, administration or the chat, content moderation, and adding and removing participants.

Fellowship Development (Saturday)

- We currently have 2 IDT's (Issue Discussion Topics) available.
- Gender-Neutral and Inclusive Language in NA Literature.
 - Important Note: The purpose of this workshop was only to discuss the potential pros and cons of gender neutral language in NA literature. It was NOT to discuss or propose making any actual changes whatsoever to our literature.

• This IDT was workshopped at length on Saturday.

 \circ It included a PowerPoint presentation, a large group discussion, and round table discussions, followed by each group presenting their findings.

Guide Meeting (Saturday)

 \circ Composition: The panel consists of up to (5) individuals elected by a simple majority of the FRSC. Up to (3) panel members and up to (2) interim panel members. Interim panel members will have limited access to sensitive

information. This commitment can be held while holding other region level positions as the panel members will not carry a voice on the regional floor.

 \circ The term for a panel member and interim panel member will be one year.

 \circ The Technology Resource Panel is accountable to the FRSC.

 \circ Clean time requirement is 4 years for a panel member and 1 year for an interim panel member.

• The panel will meet monthly, virtually.

• Spiritual impact: Concept Three.

 \circ Financial impact: One hotel room for 2 nights, for GSR Assembly and FSS, \$350 yearly.

Per the discussion on the floor and decision by the Facilitator, the HRP Leader was determined to be an open, vacant position, with the previous HRP member, Linda, requiring re-election before being able to assume that position. Any access given to the HRP Leader will not be given until a full election has taken place.

Note: After the FRSC minutes were posted and distributed, Linda submitted a letter informing the FRSC that she has completed her commitment and will not be seeking another term.

Notes: In regard to the Tampa Funcoast proposal for term limits. Per FRCNA Board and RSO Board Reports:

FRCNA, Inc Response to FRSC Admin:

FRCNA, Inc met and discussed the term limit proposal at our board meeting Sept 16. We are

unanimously opposed to term limits. We understand RSO is not opposed but we also acknowledge that each corporation is different and has unique responsibilities. We believe the board has self-imposed term limits. Half of the board is elected annually, and these positions can be filled by any member of the Florida region. Further explanation of our position in opposition to the proposal is included here:

• The requirements for being considered for a position require a minimum of 1 year on a support committee which includes organization and execution of a convention to assure the candidate fully understands the position of BOD member.

• Using past experience as an example when there was a break in continuity there was a 5-year period of "turmoil" in which money was misappropriated, funds were not donated to the Region, and there were multiple other issues which resulted in the current Admin members being asked to step in and take positions to redirect and reorganize FRCNA.

• Over the past several years, there have been open positions available to be filled with no candidates approaching HRP or the BOD for interviews.

• The BOD consists of one (1) intern position that supports anyone shadowing to learn the skill specific positions (CFO, Hotel Liaison) – this position has never had a candidate / member.

• The FRC BOD is a working board that not only organizes but executes the convention, to include contracts, vendors, hotel negotiations, etc. Vs. the RSO Board which is specific for voting and administrative purposes. It would be similar to requiring the RSO Special Workers to have "employment" limits.

• The consequences of term limits without alternates without the availability of qualified people to step into key positions could be disastrous for example CFO.

RSO Board Response:

We discussed The proposal for term limits. There was a lot of discussion. **There was broad support for term limits of some sort but no consensus on what they should be.** We need to point out that you elect 5 members every year and those members help the board elect 4 positions every 2 years. So there are term limits in effect. The RSO BOD is opposed to the proposal **as written.**

NOTE: Per our (RCMs) hand-written notes on Sunday, there was mention (during the RSO report) of possibly a 10 year term limit, although this was not in their written report submitted to the RSC Secretary.
