Outcome: Elected Treasurer Report:

On January 1, 2024, the opening available balance was \$55,362.23. After deposits of \$19,112.91 and expenses of \$11,067.10 on February 29, 2023, the ending available balance was \$63,408.04.

After deducting \$10,000.00 withheld for the next RSC, the Prudent Reserve of \$11,000.00, the GSR Assembly Reserve of \$5,500.00, the Florida Service Symposium Reserve of \$36,000.00, and a Women in Service Donation of \$75.00, the available balance was \$833.04. As of RSC held on March 17, 2024, we received \$9,325.23 in income and had \$19,774.81 in expenses. Additionally, we allocated the monthly reserve of \$500.00 for the GSR Assembly & \$1,000.00 the Florida Service Symposium. Since this weekend was the Florida Service Symposium, the \$36,075.00 withheld over the past 3 years will be released to cover the cost of the event. Therefore, after RSC business the available balance was \$24,958.46. The information provided is for the 2023-2024 Fiscal year and does not agree with information previously reported. I performed a review and made corrections where appropriate. However, prior to May 2024 RSC, these reports may include additional revisions to reflect the proper accounting of all income and expenses due to lack of information and time allotted.

Additional Information:

- HRP intends to have an Elections Term Sheet ready in May.
- FRC Board will be providing an Elections Term Sheet.
- The FSS stays in the annual budget so funds saved for the Symposium have a line item for said funds to be applied to.
- We are having discussions around the coming Interim CAR/CAT and Groups voting. More will be revealed.
- There was lengthy discussion around the financial health of the Region and the RSO. Under current conditions, the RSO is looking at being insolvent in 12-18 months. Seven other RSO's were contacted and ours is the only one that operates without financial support from their Region.
- It was emphasized during the treasurer's report that Areas operating as independent 501c3s file their taxes. The current IRS fine for not filing is \$15,000.00
